

8. (Agreement No. 415 - Standard Oil Company) Upon motion duly made and unanimously carried, a resolution was adopted confirming the approval heretofore given by the Executive Officer for the 45th and 46 revisions of the State's participating interest in the productive area of the Rio Vista Field. Under these revisions, the State's participating interest became 9.653% and 9.606%, respectively.

This approval is granted subject to any change which might result in necessary adjustments of the basic acreage figure to be agreed upon with respect to the 11th to 12th revisions, and further subject to the Standard Oil Company agreeing to extend for a period of sixty days after the submission by Standard Oil Company to the Commission of the revised map of the Rio Vista Field which the Standard Oil Company has agreed to submit, the time within which the State might make formal objection to the 11th to 46th revisions, inclusive, of the State's percentage allotment.

9. (Possible Trespass of Elwood Upland Wells on State Land) Upon motion duly made and unanimously carried, a resolution was adopted instructing the Executive Officer to request the Attorney General to immediately proceed to obtain a court order whereunder the Commission may have surveys made of all wells suspected of trespass upon State land.

10. (Publication of Notice of Intention to Receive Bids for Oil and Gas Lease, Orange County Tidelands) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to advertise notice of intention to receive bids for oil and gas leases for all of the unleased tide and submerged area lying between the western boundary of Lease No. P.R.C. 163 at Huntington Beach and the Orange County -- Los Angeles County boundary line as extended to a point three miles seaward from the ordinary high water mark. The Executive Officer is authorized to determine and divide the area into the number and size of the parcels to be advertised, which shall in no event, however, be fewer than a total of five parcels.

The advertising shall carry the following conditions and any award made pursuant to such advertising shall be subject to such conditions:

All drill sites shall be located landward of "Alternate Highway U. S. 101" or from existing jetties which have been constructed offshore in connection with the United States Navy Ordnance development at Anaheim

Landing. Any drill sites located on such jetties shall be a distance of at least 1,000 feet seaward from the present shoreline, measured on a line drawn at a right angle to the shoreline. *See Item 12, 1445 Minutes*

Upon cessation of drilling of any well or wells into the leased premises, the Lessee shall remove any derrick or derricks which were constructed for such drilling without regard as to whether such well or wells are drilled from either the uplands or the specified jetties.

11. (Advertising of Tide and Submerged Lands Offshore from Summerland Previously Approved by the Commission) Commission Member Lieutenant Governor Houser informed the Commission that he had made a personal inspection of the proposed drill site area which is contemplated to be used for the development of the offshore Summerland area, and that he recommended that all derricks used for this drilling should be located in the presently established industrial area upon the bluff overlooking the beach and the ocean, and in no event were any derricks to be permitted on the beach or in the canyons leading down to the beach area. Governor Houser suggested further that the advertising should recite these conditions. Suggestions of the Lieutenant Governor were accepted and the Commission instructed the Executive Officer to incorporate them in the advertising for bids for lease of area.

12. (Application of Standard Oil Company to Lay a Temporary Water Line Across Montezuma Slough -- No. P.R.C. 164) Upon motion duly made and unanimously carried, a resolution was adopted confirming the approval heretofore given by the Executive Officer for a ninety day permit granted to the Standard Oil Company to lay a temporary three inch water line upon the bottom of Montezuma Slough -- Solano County for the purpose of transporting water to the well being drilled by said Company. Said permit was given provided that the Standard Oil Company pay a \$5.00 Filing fee and is subject to additional regular rental charges if the line becomes permanent.

13. (Permit to Repair Jenner Jetty, No. P.R.C. 165) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Division of Fish and Game to repair the Jenner Jetty on the east bank of the Russian River at the Pacific Ocean in Sonoma County.

This approval was given subject to the condition that the Division of Fish and Game shall file with the Commission a map of the jetty and the areas contiguous thereto.
