

15. (Certificate of Restitution No. 293 - Estate of William B. Reis). The Commission was informed that Certificate of Restitution No. 293 was issued September 12, 1946, pursuant to Section 7414 of the Public Resources Code, to the estate of William B. Reis in consideration of the surrender of Indemnity Certificate No. 1800 issued May 2, 1921, which entitled Mr. William B. Reis to have 40 acres of land selected by him for the vacant unappropriated lands of the United States for which he paid the State \$266.00. Mr. Reis died without having selected the lands to which he was entitled.

Upon motion duly made and unanimously carried, a resolution was adopted confirming the issuance of Certificate of Restitution No. 293 to the estate of William B. Reis in the amount of \$266.00.
