(PACIFIC GAS AND ELECTRIC COMPANY, APPLICATION FOR RIGHT OF WAY EASEMENT ACROSS SACRAMENTO RIVER, SACRAMENTO COUNTY - V.O. 1953, P.R.C. 611) Pacific Gas and Electric Company has applied for a right of way easement 100 feet in width and 611 feet in length across Sacramento River approximately two and one-half miles northeasterly of Isleton for the installation, maintenance and use of pipe lines for conveying gas. It is requested that the easement issue for a period of fifteen years with right of renewal for three additional periods of ten years each. Rental for the fifteen year period at the established race of \$10.00 plus 2¢ per lineal foot will be \$52.22 annually. Filing fee and expense deposit have been paid.

UPON NOTION DULY HADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO PACIFIC CAS AND ELECTRIC COMPANY A RIGHT OF WAY EASEMENT 100 FEET IN WIDTH AND 611 FEET IN LENGTH ACROSS SACRAMENTO RIVER APPROXIMATELY TWO AND ONE-HALF MILES HORTHEASTERLY OF ISLETON FOR THE INSTALLATION, MAINTENANCE AND USE OF PEPELINES CONVEYING CAS FOR A PERIOD OF PIFTEEN ISLANS AT AN ANNUAL RENTAL OF \$52.22 WITH THE RICHT OF RENEWAL FOR THEER ADDITIONAL PERIODS OF TEN YEARS EACH AT SUCH TERMS AS MAY BE DETERMINED PRIOR TO EACH RENEWAL DATE, PERFORMANCE BOND IN THE ANCIENT OF \$1,000 TO HE COVERED BY THE \$50,000 BLANKET BOND PURNISHED ON MAY 1, 1954.

5. (RESERVATION OF MIMERAL DEPOSITS, PORTION OF LANDS OF MAPA STATE HOSPITAL, NAPA COUNTY - GEO. NAPA COUNTY) A request has been received from the Department of Finance for approval, pursuant to Section 6004 of the Public Resources Code, of a reservation to the State of all minerals in an area to be conveyed by the State through the Department of Finance to one Beebe J. Robinson.

Section bids of the Public Recourses Code provides: "Any state agency that sells any of the lands listed in Section 5003, other than tex-decided lands, cay, with the approval of the State Lands Commission, reserve to the State any or all oil, gas, oil shale, coal, phosphate, sodium, gold, silver, or other mineral deposits therein, together with the right to prospect for, wine, and remove such deposits, and to occupy and use so much of the surface of the land as may be necessary therefor".

The land to be conveyed is in an area which has been subjected to continuing appredic prospecting for minerals, including oil and gas. The quitclaim deed being issued for these lands contains an adequate reservation to the State of all minerals.

UPON MOTION DULY HADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE A RESERVATION TO THE STATE, PURSUANT TO PUBLIC RESOURCES CODE SECTION 64.04, OF ALL DEPOSITS OF MINERALS IN THE 183.6 ACRES IN THE STATE THROUGH THE DEPARTMENT OF PINANCE TO BEEBE J. ROBINSON BY QUITCLAIM DEED DATED AFRIL 13, 1951.
