(REFUND OVERPAYMENT OIL ROYALTIES, LEASES NOS. 48, GENERAL PETROLEUM CORPORATION, \$15.30; 92, PACIFIC WESTERN OIL CORPORATION, \$66.25; 93, PACIFIC WESTERN OIL CORPORATION, \$243.62; 98, WILLIAM L. APPLEFORD, \$116.68; P.R.C. 129, SIGNAL OIL AND GAS COMPANY, \$5.13; P.R.C. 144, FULLERTON OIL COMPANY, \$39.32; 90, HONOLUTU OIL CORPORATION, \$129.92; 91, SEAWARD OIL CO., LTD., \$104.54; 163, B. D. OWENS, \$16.41 - W.O. 456-10.) At its meeting held April 27, 1949, in Sacramento, the Commission was advised of action being taken by the Division of State Lands to close balances of accounts receivable with tideland lease operators as of June 22, 1947. As previously recited, these balances resulted from an accumulation of differences under the prior lease years. It was pointed out that as they accrued, claims for refunds due certain lessee accounts having a credit balance on the records of the Division due to overpayment of royalties would be presented to the Commission for action.

Claims from certain of the tideland lease operators, properly executed, have now been received, and were presented to the Commission for approval.

Army Corps of Engineers has applied for a permit to construct a pier extending into the Santa Barbara Channel from Santa Rosa Island, the pier to be used for classified military purposes. No fee or rental is required.

UPON MOTION DULY MADE AND UKANIMOUSLY CARRIED A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE U.S. ARMY CORPS OF ENGINEERS, A PERMIT TO CONSTRUCT A VIEW EXTENDING INTO THE SANTA BARBARA CHANNEL FROM SANTA ROSA ISLAND, SAID PIEW TO BE USED FOR CLASSIFIED MILITARY PURPOSES, THE CONSIDERATION BEING THAT THE PROPOSED INSTALLATION IS IN THE INTEREST OF THE PUBLIC.
