Section 6444 of the Public Resources Code provides: "Whenever in the judgmont of the commission it is to the advantage of the State to exchange any of its public lands, as provided in Sections 6441, 6442 and 6443, the commission shall so certify to the Governor, who shall thereupon execute, on behalf of the State, any instruments of conveyance pecessary to effect the exchange."

It is proposed that the State acquire this land and sell it after publication of notice to receive bids at a price of not less than \$2,00 per acre. This price has been approved by the staff after inspection.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED A RESOLUTION WAS ADOPTED, PURSUANT TO SECTION 7405.1 OF THE PUBLIC RESOURCES CODE, APPROVING THE SELEC-TION OF THE SUBJECT LAND AND CERTIFYING THAT IT IS TO THE ADVANTAGE OF THE STATE TO EXCHANGE THE 5495.60 ACRES OF SURVEYED SCHOOL LANDU IN THE JOSHUA THE MATIONAL MODULENT IN SAM REPRESENTED AND RIVERSIDE COUNTIES, OFFERED TO THE UNITED STATES IN EXCHANGE FOR 5489.34 ACRES OF GOVERNMENT LANDS IN T. 10 S., R. 10 H., S.B.M., INFERIAL COUNTY, OF APPROXIMATELY ROUAL AREA AND VALUE, AND AUTHORIZING THE EXECUTIVE OFFICER TO EXECUTE, ON BEHALF OF THE STATE LANDE COUNTSTON, THE CERTIFICATE PROVIDED FOR IN SECTION 6444 OF THE FUBLIC EXECUTIVES CODE.

THE COMMISSION FURTHER AUTHORIZED THE EXECUTIVE OFFICER TO ADVERTISE AND RECEIVE BIDS FOR THE SALE OF SAID 5489.34 ACRES AT A MINIMUM PRICE OF \$2.00 PER ACRE, GIVING COLONEL BLLSFORTH THIRTY DAYS AFTER OFFICE OF BIDS IN WHICH TO MEET THE RECEPT GUALIFIED BIDS, AND REPORTING THE RESULTS TO THE COMMISSION FOR FINAL ACTION.

The Countration was informed that at the mosting of February 25, 1949, at Page 952 of the Minutes, Item 39, it approved the selection of 6440 mores in Pakrump Valley in behalf of Roland H. Wiley of Las Vegas, Nevada.

On March 23, 1950, Page 1100 of the Minutes, Item 7, the Complasion authorised the sale, upon the approval of the selection, to Mr. Wiley without advertising, at a cash price of \$2.00 per sore for said 6440 acres of federal government land.

On April 27, 1949, Pages 954 and 955 of the Minutes, Item 21, the Commission Authorized the selection of an additional 3074.50 acres of federal land in Fahrung Valley and its sale, upon approval of the selection, to Mr. Wiley at a cash price of \$2.00 per sore.

On Movember 21, 1949, Pages 1038 and 1039 of the Minutes, Item 52, the Commission muthorised the selection of an additional 49.55 acres of federal land in the Pabrump Valley, which is contiguous to the lands previously selected in behalf of Mr. Wiley. The Commission further authorized the execution of a certificate to accompany to the Sovernor's office a grant deed to the federal government covering 9575. Il scress of State lands in the Death Valley Mational Momment offered to the United States for government lands of equal area and value, selected in behalf of Mr. Wiley as above extlined. Said 9575.11 acress of State Lands were accordingly conveyed to the United States by the State by grant deed executed by the Governor on November 22, 1949, and on February 17, 1950, the 9567.12 acres of government lands selected in behalf of Mr. Wiley were presented to the State by the United States,

On December 21, 1939, at Page 1053 of the Minutes, Item 27, S.W.O. 137 and S.W.O. 5207, at the request of Mr. Roland H. Wiley, the Commission authorized the selection of an additional 4400.73 acres of federal government land in the Pahrump Valley in accordance with Section 7405.1 of the Public Resources Code.

Cn December 28, 1949, pursuant to said authorization, the State's application to select 4400.75 acres of federal government land in T. 21 N., H. 10 E., and T. 22 N., R. 10 E., S.B.M., Invo County, was filed in the office of the Bureau of Land Management at Sacramento and given Serial No. 042150.

On February 16, 1951, the Bureau of Land Management at Washington, D. C., advised that: "An examination of our records shows that there are no springs or water holes meeded or used by the public for watering purposes, and no hot or medicinal springs, on the selected lands. It has been determined that the selected lands are available for exchange and that the values of the selected and offered lands are approximately equal for the purpose of the exchange. There are no outstanding contests or protests of record. The requirements pertaining to the application contained in 45 GFR, Part 147, have been met, and pursuant to Sec. 2.65 (a) of departmental Order 2588 of August 16, 1950 (15 F.R. 5846), publication of this exchange is authorised."

In accordance with instructions from the Sursey of Land Management, the notice of the exchange application describing both government lunds and State lands was published for the required period in the newspaper designated by the Bureau of Land Management.

Before the government land desired by Mr. Wiley will be patented to the State, it is moves sary for the State to convey to the federal government by grant deed the 4400 mores of State lands in Death Valley Haticmal Momment offered in exchange.

Section 6444 of the Public Resources Code provides: "Whenever in the judgment of the Commission it is to the advantage of the State to exchange any of its public lands, as provided in Sections 6441, 6442 and 6443, the Commission shall so certify to the Governor, who shall thereupon execute, on behalf of the State, any instruments of conveyance more says to effect the exchange."

It appears that the Commission has never authorized the sale of the 4400.75 acres to Mr. Wiley, although the application was made by the State in his behalf. The land has been examined and it is the opinion of the staff that the minimum price of \$2.00 per acre for the entire area is the maximum value under the present conditions.

WILEY THIRTY DAYS AFTER OFENING OF BIDS IN WHICH TO MEET THE SIGNEST QUALIFIED BIDS, AND REFERING THE RESULTS TO THE COMMISSION FOR FIREL ACTION.
