8. (APPLICATION FOR LEASE OF TIDE AND SUBMERGED LANDS, CARQUINEZ STRAITS, CONTRA COSTA COUNTY, CROCKETT STRIPED BASS CLUB, INC. - W. O.1078, P.R.C. 659.) The Crockett Striped Bass Club, Inc. has applied for a lease of approximately 1.5 acres of tide and submerged lands in Carquines Straits, Contra Costa County, now under Extensent 22, issued under Chapter 675, Political Code, expiring on July 18, 1952. Rental under the existing essement is \$72 annually, no bond required. A wharf of considerable size occupies the area. The adjacent tide and submerged land, under lease to the California and Hawaiian Sugar Refi ing Corporation, has been apprecised by two appraisers at \$1000 and \$500 per acre. The average of these two figures, namely, \$750 per acre, is therefore taken as the value of the land which the applicant wishes to lease. Annual rental at 6.6 percent of such land value under the proposed lease will be \$78.16 for a fifteen-year period. Because of the wharf on the area, it is considered that performance bond in the amount of \$5000 should be required. Filing fee and expense deposit have been paid.

UPON MOTION DULY MADE AND UMANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE CROCKETT STRIPED BASS GLUB, INC. A LEASE OF APPROXIMATELY 1.5 ACRES OF TIDE AND SUBMERGED LAND IN CARQUINEZ STRAINS, CONTRA COSTA COUNTY, FOR FIFTEEN YEARS, EFFECTIVE JULY 19, 1952, UPON TERMINATION OF THE EXISTING LEASE, AT AN ANNUAL RENTAL OF \$78.16, WITH RIGHT OF REMEWAL FOR AN ADDITIONAL TEN YEARS AT SUCH TERMS AS MAY BE DETERMINED PRICE TO REMEMAL, PERFORMANCE BOND IN THE AMOUNT OF \$5000 TO BE FURNISHED.

9. (SALE OF VACANT STATE LANDS, APPLICATION 4818, SACRAMENTO LAND DISTRICT, SANTA CLARA COUNTY, JAMES K. STONIZR - S.W.O. 5369.) An offer has been received from Mr. Stonier of San Jose, California, to purchase the SWF of SWF, By of SWF, and Mr of SEF of Section 36, T. 7 S., R. 4 E., M.D.M., containing 200 mores in Santa Clara County.

hr. Stonier made an offer of \$400, or \$2 per acre. The Assessor of Santa Clara County has assessed contiguous lands at \$1.85 to \$5 per acre, thus indicating a market value of those lands of \$3.70 to \$6 per acre.

The land, at an elevation of from 2000 to 2400 feet, is mountainous and cut by canyons, with about third-grade soil. It contains one small intermittent spring, its cover consists of chaparral, heavy chamise and buck brush, and it is very poor for grasing. Access is by an existing private road one-fourth mile away, through three looked gates. In view of these conditions the Commission's staff appraised the land at \$5 per sore, and Kr. Stonier has increased his offer and deposit secondingly.

The land was advertised for sale with a stipulation that no offer of less than \$600 would be accepted. Mr. Stonior bid \$600.
