17. (APPLICATION FOR PERMIT TO CONSTRUCT PIER, LAKE TAHOE, PLACER COUNTY, W. D. PATTERSON, JR.- W.O. 1300, P.R.C. 748.1.)

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO W. D. PATTERSON, JR., A TWO-YEAR PERMIT FOR CONSTRUCTION, MAINTENANCE, AND USE OF A RECREATIONAL PIER IN LAKE TAHOE, PERMIT FEE TO BE \$20, TERMS OF THE PERMIT BEING SUBJECT TO REVISION AT THE END OF THE TWO-YEAR PERIOD.

18. (APPLICATION FOR PERMIT TO CONSTRUCT A PIER, LAKE TAHOE, PLACER COUNTY, R. A. HAIGHT - W.O. 13 Ol. P.R.C. 749.1.)

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO R. A. HAIGHT A FERMIT TO CONSTRUCT, MAINTAIN, AND USE A RECREATIONAL PIER IN LANE TANCE FOR A PERIOD OF TWO YEARS AT A PERMIT FEE OF \$20, TERMS OF THE PERMIT TO BE SUBJECT TO REVISION AT THE END OF THE TWO-TEAR PERIOD.

19. (AMENDMENT OF LEASE P.R.C. 185, SANTA CATALINA ISLAND, LOS ANGELES COUNTY, SANTA CATALINA ISLAND COMPANY - W.O. 1280.) The Santa Catalina Island Company holds Lease P.R.C. 185, covering seventeen percels of tide and submerged lands adjacent to Santa Catalina Island. The lease, effective August 29, 1950, runs for fifteen years at an annual rental of \$1,293.60. Due to the increase in yachting activity, the Company has been asked to grant permission for the installation of mooring buoys in an additional cove. In order to administer the proposed mooring location properly, the Company has requested that Lease P.R.C. 185 be smended by the addition of another parcel of approximately three excess in an unmaned cove east of Smelts Cove and between Howland's Landing and Cherry Valley Cove. U.S. Treasury Bonds in the amount of \$5000 have been deposited with the State Treasurer in lieu of surety bond. The value of the additional area is approximately \$300, indicating an additional rental of \$19.80.

UPON NOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE SANTA CATALINA ISLAND COMPANY AN AMENDMENT TO LEASE P.R.C. 185, SUCH AMENDMENT TO ADD APPROXIMATELY THREE ACRES ADJACENT TO SANTA CATALINATSLAND IN AN UNNAMED COVE EAST OF SMELTS COVE AND BETWEEN HOWLAND'S LANDING AND CHERRY VALLEY GOVE, ANNUAL RENTAL TO BE INCREASED FROM \$1,293.60 TO \$1,313.40, EFFECTIVE AUGUST 29, 1952, ALL OTHER TERMS AND CONDITIONS TO REMAIN UNCHANGED.

20. (TRANSFER OF JURISDICTION OF SNAMP AND OVERFLOWED LANDS TO DEPARTMENT OF FISH AND GAME, NORTH EEL RIVER SANDSPIT, HUMBOIDT COUNTY - W.C. 1288, J.T.C. 1.) Discussions have been held between the Staff and the Division of Beaches and Parks, and by Mr. Deam with the Wild Life Conservation Board with respect to bransfer of jurisdiction of Lot 2 of Section 1, Lots 1, 2, 5, and 6 of Section 9, Lot 2 of Section 10, and Lots 3 and 4 of Section 16, T. 3 N., R. 2 W., H.M., containing 168.19 acres of sweep and overflowed lands in Humboildt County on what is known as the North Bel River Sandspit. This land is not subject to any trust such as school lands or tide lands.

Mr. Newton B. Drury, Chief, Division of Beaches and Parks, has been advised that acquisition of this property was discussed at a recent meeting with the Humboldt County Planning Commission. All involved agreed that the property should remain under State ownership and should not be permitted to be sold
