17. (APPLICATION FOR PERMIT TO CONSTRUCT PIER, LAKE TAHOE, PLACER COUNTY, W. D. PATTERSON, JR.- W.G. 1300, P.R.C. 748.1.)

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO N. D. PATTERSON, JR., A TWO-YEAR PERMIT FOR CONSTRUCTION, MAINTENANCE, AND USE OF A RECREATIONAL PIER IN LAKE TAHOE, PERMIT FEE TO BE \$20, TERMS OF THE PERMIT BEING SUBJECT TO REVISION AT THE END OF THE TWO-YEAR PERIOD.

18. (APPLICATION FOR PERMIT TO CONSTRUCT A PIER, LAKE TAHOE, PLACER COUNTY, R. A. HAIGHT - W.O. 1301, P.R.C. 749.1.)

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO R. A. HAIGHT A PERMIT TO CON-STRUCT, MAINTAIN, AND USE A RECREATIONAL PIER IN LAKE TAHOE FOR A PERIOD OF TWO YEARS AT A PERMIT FEE OF \$20, TERMS OF THE PERMIT TO BE SUBJECT TO REVI-SION AT THE END OF THE TWO-YEAR PERIOD.

19. (AMENDMENT OF JEASE P.R.C. 185, SANTA CATALINA ISLAND, LOS ANGELES COUNTY, SANTA CATALINA ISLAND COMPANY - W.O. 1280.) The Santa Catalina Island Company holds Lease P.R.C. 185, covering seventeen parcels of tide and submerged lands adjacent to Santa Catalina Island. The lease, effective August 29, 1950, runs for fifteen years at an annual rental of \$1,293.60. Due to the increase in yachting activity, the Company has been asked to grant permission for the installation of mooring buoys in an additional cove. In order to administer the proposed mooring location properly, the Company has requested that Lease F.R.C. 185 be amended by the addition of another parcel of approximately three acres in an unnamed cove cast of Smelts Cove and between Howland's Landing and Cherry Valley Cove. U.S. Treasury Bonds in the amount of \$5000 have been deposited with the State Treasurer in lieu of surety bond. The value of the additional area is approximately \$300, indicating an additional rental of \$19.80.

UPON MOTION DULY MADE AND UNANIMOUSLI CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE SANTA CATALINA ISLAND COMPANY AN AMENDMENT TO LEASE P.R.C. 185, SUCH AMENDMENT TO ADD APPROXI-MATELY THREE ACRES ADJACENT TO SANTA CATALINA ISLAND IN AN UNNAMED COVE EAST OF SMELTS COVE AND BETWEEN HOWLAND'S LANDING AND CHERRY VALLEY COVE, ANNUAL RENTAL TO BE INCREASED FROM \$1,293.60 TO \$1,313.40, EFFECTIVE AUGUST 29, 1952, ALL OTHER TERMS AND CONDITIONS TO REMAIN UNCHANCED.

20. (TRANSFER OF JURISDICTION OF SMAMP AND OVERFLOWED LANDS TO DEPARTMENT OF FISH AND GAME, WORTH EEL RIVER SANDSPIT, HUMBOLDT COUNTY - W.O. 1288, J.T.O. 1.) Discussions have been held between the Staff and the Division of Beaches and Parks, and by Mr. Dean with the Wild Life Conservation Soard with respect to transfer of jurisdiction of Lot 2 of Section 4, Lots 1, 2, 5, and 6 of Section 9, Lot 2 of Section 10, and Lots 3 and 4 of Section 16, T. 3 N., R. 2 W., H.M., containing 168.19 acres of swamp and overflowed lands in Humboldt County on what is known as the North Eel River Sandspit. This land is not subject to any trust such as school lands or tide lands.

Mr. Newton B. Drury, Chief, Division of Beaches and Parks, has been advised that acquisition of this property was discussed at a recent meeting with the Humboldt County Planning Commission. All involved agreed that the property should remain under State compoship and should not be permitted to be sold

to private interests. The Humboldt County Master Plan calls for acquisition of the South Humboldt Bay Sandspit by the Department of Fish and Game, and it is believed by Mr. Drury that the lands on the North Eel River Sandspit, described above, should be included under the program.

Inquiries have been made by individuals for private acquisition of this land, whereby \$336.38 or \$2 an acre was offered. In view of the public interest indicated by the Division of Beaches and Parks and the Department of Fish and Game, it is the opinion of the Staff that the property should be transferred to the Department of Fish and Game. Transfer would be made pursuant to Section 13110 of the Government Code, which requires approval by the Director of Finance.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE TRANSFER OF JURISDICTION TO THE DEPARTMENT OF FISH AND GAME OF LOT 1 OF SECTION 4, LOTS 1, 2, 5, AND 6 OF SECTION 9, LOT 2 OF SECTION 10, AND LOTS 3 AND 4 OF SECTION 16, T. 3 N., R. 2 W., H.M., CONTAINING 168.19 ACRES OF SWAMP AND OVERFLOWED LANDS IN HUMBOLDT COUNTY, FURSUANT TO SECTION 13110 OF THE GOVERNMENT CODE, AND THAT TRANSFER AGREEMENT BE SUBMITTED TO THE DIRECTOR OF FINANCE FOR APPROVAL.

21. (MINERAL EXTRACTION LEASE P.R.C. 382, SAN BERNARDINO COUNTY, INSULATION MINING AND MILLING COMPANY.) Lease P.R.C. 382, issued July 6, 1950, covering 40 acres in the SWA of the SWA of Section 36, T. 31 S., R. 44 E., M.D.M., and assigned to Insulation Mining and Milling Company on May 8, 1951, provides in part that the lessee shall complete at least 720 shifts of mining operations on the demised premises during each year of the term of the lease. The lease was issued for the purpose of extraction of perlite and other nonmetallic minerals. Annual rental has been paid to July 1, 1953. The Lessee has reported that while no mineral extraction operations were conducted during the lease year 1951-1952, approximately \$16,000 has been expended for the installation of mining equipment on the premises to permit the processing of the perlite to be mined. In addition, the Lessee has under negotiation an operating contract for substantial mineral extraction during the forthcoming lease year. In consideration of these factors, the Lessee has requested that declaration of a default under the lease be withheld to permit the initiation of active operations under the lease and to protect the investment in the processing equipment installed.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO WITHHOLD SERVING A NOTICE OF DEFAULT AND CANCELLATION OF LEASE P.R.C. 382 FOR A PERIOD OF ONE YEAR FROM JULY 6, 1952, THE BASES FOR ANY FURTHER CONTINUATION OF THE LEASE TO BE DETERMINED FROM OPERATING PERFORMANCE BY THE INSULATION MINING AND MILLING COMPANY DURING THE PERIOD AUTHORIZED HEREIN.

22. (BID FOR SAND AND ORAVEL LEASE, TIDE AND SUBMERCED LANDS, ROCHAWAY BEACH, SAN MATEO COUNTY, KEN ROYCE, INC. - W.O. 1095.) On July 15, 1952, one bid was received from Ken Royce, Inc. in response to a published Notice of Intention of the State Lands Commission to receive offers to enter into a lease for the extraction of sand and gravel from approximately five acres of tide and submerged Lands at Rockaway Beach, San Mateo County. Publication of this offer was authorized by the Commission on May 26, 1952. The bid submitted by Ken Hoyce, Inc. has been reviewed by the Staff and found to be qualified. The
