The soil is of second quality; there is an annual stream on the land; and the graze is fair. The land supports patches of noncommercial timber of Louglas Fir, Bull Pine, and Scrub Oak, and heavy chaparral. The land is accessible by an existing private road through the applicants' fee land.
