- 2. Upon motion duly made and unanimously carried, it was resolved that the next meeting of the state lands commission would be held in sacramento on wednesday, makes 9, 1955, at 10 a.m., in the office of the director of finance.
- 3. (SALE OF VACANT SCHOOL LAND, APPLICATION NO. 5061, SACRAMENTO LAND DISTRICT, HONO COUNTY, F. M. FULSTONE S.W.O. 5862.) The following report was presented to the Commission by the staff:

"An offer has been received from F. M. Fulstone of Smith, Nevada, to purchase the SET of Section 36, T. 4 N., R. 24 E., M.D.M., containing 160 acres in Mono County. Mr. Fulstone made an offer of \$960, or \$6 per acre.

*The Assessor of Mono County has assessed contiguous land at \$1.75 per acre, thus indicating its appraised value to be \$3.50 per acre.

"An inspection and appraisal by a member of the Commission's staff on November 16, 1954, sets the value of the subject land at \$5 per acre.
