- 44. (VACANT FEDERAL LAND, OBTAINED THROUGH USE OF BASE, LIEU LAND APPLICATION NO. 10646-A, LOS ANGELES LAND DISTRICT, SAN BERNARDINO COUNTY, GEORGE MCCARTHY - S.W.O. 5718.) The following report was presented to the Commission:

"An offer has been received from George McCarthy of Apple Valley, California, to purchase the E $\frac{1}{2}$, N $\frac{1}{2}$ of Lot 1 of NW $\frac{1}{4}$, Lot 2 of NW $\frac{1}{4}$ and Lot 2 of SW $\frac{1}{4}$ of Section 19, T. 4 N., R. 3 E., S.B.M., containing 517.72 acres in San Bernardino County. This land may be obtained by the State from the Federal Government through use of base. Mr. McCarthy made an offer of \$2,588.60, or \$5 per acre.

"An inspection and appraisal by a member of the Commission's staff on January 18 and February 3, 1956 establishes the value of the subject land as ranging between \$18 per acre minimum and \$20 per acre maximum. The applicant has objected to these valuations on the basis that they are excessive, and a reappraisal by a member of the staff is currently in process. However, in view of the location of the lands and their proximity to Apple Valley it is considered desirable to have a finding by the Commission that the State should proceed with acquisition from the Federal Government. The State's indemnity selection application has been accepted by the Bureau of Land Management, subject to future approval and listing.

"The selection of the subject land is considered to be to the advantage of the State in that the selection thereof will assist the State in satisfying the loss to the School Land Grant and in addition will place said land on the tax rolls of the county in which it is situated following sale thereof by the State. Furthermore, the lands are not suitable for cultivation without artificial irrigation."

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:
