5. CANCELLATION OF MINERAL EXTRACTION LEASE, MONO COUNTY - P.R.C. 598.1.)

After presentation of Calendar Item 10 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO CANCEL MINERAL EXTRACTION LEASE P.R.C. 598.1, MONO COUNTY, DUE TO THE FAILURE OF THE LESSEE TO COMPLY WITH THE RULES AND REGULATIONS OF THE COMMISSION AND TO PAY THE REQUIRED RENT. IN THE EVENT THAT THE AMOUNT DUE IS NOT FULLY PAID, THE ATTORNEY GENERAL IS TO BE REQUESTED TO TAKE THE REQUIRED STEPS TO FORCE COLLECTION OF THE AMOUNT DUE.

(CANCELLATION OF MINERAL EXTRACTION LEASE, MONO COUNTY - P.R.C. 598.1.)

Mineral Extraction Lease P.R.C. 598.1 covering an area in Mono Lake in Section 14, T. 1 N., R. 26 E., M.D.B.& M., was issued to Mrs. Lou Williams of Leevining, California, February 28, 1951 pursuant to competitive public bidding.

Section 3 of the lease provides in part that the lessee will pay to the State the annual rental without deduction, default or delay. In the event of the failure of the lessee to do so, it shall be lawful for the State to re-enter into and upon the demised premises and repossess and enjoy the premises as in the first and former estate of the State. The lessee has been notified that the annual advance rental in the amount of \$50 for the years 1955 and 1956 has not been received. Lessee's Quarterly Reports of Operations and Quarterly Statements of Shipments and Sales have not been submitted since March 31, 1955. In a letter dated February 8, 1956, Mrs. Lou Williams stated that she was unable to make the rental payment. Further correspondence has been returned bearing the postal stamp "Unknown at this Address".

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO CANCEL MINERAL EXTRACTION LEASE P.R.C. 598.1, MONO COUNTY, DUE TO THE FAILURE OF THE LESSEE TO COMPLY WITH THE RULES AND REGULATIONS OF THE COMMISSION AND TO 1 THE REQUIRED RENT. IN THE EVENT THAT THE AMOUNT DUE IS NOT FULLY PAID, THE ATTORNEY GENERAL IS TO BE REQUESTED TO TAKE THE REQUIRED STEPS TO FORCE COLLECTION OF THE AMOUNT DUE.
