(SALARY RATES, CONSULTING GEOLOGIST AND PETROLEUM ENGINEER AND CONSULTING SEACOAST ENGINEER - PERSONNEL.)

On July 1, 1956 and January 18, 1957, the State Personnel Board adjusted the respective salary ranges for the classes Consulting Geologist and Petroleum Engineer and Consulting Seacoast Engineer from \$0. - \$100. per day to \$0. - \$150. per day. This action was taken subsequent to, and upon the recommendation of the Board's staff, after a study of prevailing rates being paid for services of this type.

The State Lands Division employs Milton W. Lewis, as a Consulting Geologist and Petroleum Engineer, and Charles T. Leeds, as a Consulting Seacoast Engineer, both on an intermittent basis. Both of these men are recognized as being well qualified in their fields.

Recently these appointees have made representations that the rate being paid for their services by the Division is not commensurate with that being paid them by private industry and other public bodies; that their agreed upon fees with these other State agencies are at the rate of \$150. per day.

Based on the State Personnel Board's action, the representations made by the individuals involved, and the further fact that both employees were previously being paid at a maximum;
