By action of the State Lands Commission, at its meeting held April 8, 1957, a resolution was unanimously adopted directing that all bids be rejected for the purchase of the  $S_{\overline{z}}$  of Section 16, T. 9 N., R. 15 W., S.B.M., on the basis of noncompliance by the Mojave Desert News with publication instructions. The action of the Commission was as follows:

"THE COMMISSION REJECTS ALL BIDS AND APPLICATIONS RECEIVED FOR THE  $S\frac{1}{2}$  OF SECTION 16, T. 9 N., R. 15 W., S.B.M., CONTAINING 322.80 ACRES IN KERN COUNTY, SET FORTH IN THE ATTACHED TABULATION, DIRECTS THE RETURN OF ALL BIDS AND APPLICATIONS RECEIVED WITH NO RELEASE OF INFORMATION WITH RESPECT TO THE PRICES BID, AND AUTHORIZES REPUBLICATION FOR RECEIPT OF NEW BIDS."

In accordance with the above action, publication of notice of sale was reordered and the following bids received pursuant thereto:

All bids received were in proper form and in accordance with the published notice. There were no applications on file with the Commission prior to republication of notice of sale. Therefore, the regulation providing for the right of a first applicant to meet the highest bid is not applicable. Subsequent to the original publication of notice of sale in February, a right-of-way for an underground aqueduct, together with an access road, was granted to the Los Angeles City Department of Water and Power under P.R.C. 1901.9. Pursuant to the provisions of Section 6210.4a of the Public Resources Code, the area embraced in the aforesaid grant must be reserved by the State. The land value, however, has not been altered by reason of the reservation of this area.

# PARCEL 3

A strip of land 30 feet in width lying 15 feet on each side of the following described centerline:

Beginning at "Point B" as described in Parcel 2 above; thence South 55° 27' 25" East 230.06 feet; thence South 33° 59' 36" East 112.11 feet to "Point A" as described in Parcel 1 above.

The side lines of said 30 foot wide strip of land are to be prolonged or shortened so as to commence on the southerly line of that certain course of Parcel 2 described above as having a bearing of North 81° 09' 48" East and distances of 42.00 feet and 198.86 feet, and to terminate on the northwesterly line of said Parcel 1.

Containing in the three parcels a net area of 13.91 acres.

The basis of bearings for the purpose of the descriptions contained in Parcels 1, 2 and 3 above is taken from the Government Township Plat 9 North, Range 15 West, S.B.M. dated November 4, 1922, as being North 89° 53' 00" West along the south line of Section 16.
