(1957 LEGISLATION - W.O. 2115.)

The final status of the principal legislative bills considered at the recent legislative session and affecting the administrative cognizance of the Commission is tabulated in the following:

<u>BILL NO., AUTHOR, AND ABSTRACT</u>	<u>STATUS</u>
<u>S. 15</u> (Breed) Conveys 3000 acres of tide and submerged lands to City of Oakland for utilization in an airport extension.	Approved. Ch. 709.
<u>S. 40</u> (Gibson) Conveys tide and submerged lands adjoining Mare Island to the City of Vallejo.	Approved. Ch. 1501.
<u>S. 99</u> (McCarthy) Authorizes exchange of State tide and submerged lands by the State Lands Commission for equivalent value of privately owned lands adjoining Corte Madera Creek, Marin County, without mineral reservations.	Approved. Ch. 17.
<u>S. 309</u> (Erhart) Corrects Ch. 647, Stats. 1955 (grant of tide and submerged lands to Port San Luis Harbor District), to transfer pre-existing State commercial leases within the geographic limits of the grant.	Approved. Ch. 302.
<u>S. 565</u> (Murdy) Permits deposit in ocean of clean water resulting from well drilling operations. Authorizes amendment of existing oil and gas leases to permit any operational advantages which have been authorized by statutory modifications after issuance of the original lease.	Approved. Ch. 104.
<u>§) 1054</u> (Cunningham) Repeals Sections 6211 and 6212, Public Resources Code, to eliminate requirements for reporting on repealed Torrens Title Registration.	Approved. Ch. 1672.

<u>S. 1076</u> (H. Johnson) Eliminates necessity of approval by the State Lands Commission to the reservation of mineral rights to the State in a sale of State lands by another State agency.	Approved. Ch. 1675.
<u>S. 1095</u> (Regan) Authorizes delegation of authority to employees to conduct public hearings.	Approved. Ch. 1906.
<u>S. 1517</u> (Arnold) Authorizes State Lands Commission to sell abandoned channel of Guadalupe Canal, San Mateo County, and accreted tide and submerged land in Gallinas Canal, Marin County.	Approved. Ch. 1701.
<u>S. 1550</u> (Gibson) Corrects legal description of lands conveyed in Ch. 483, Stats. 1947, Tide and Submerged Lands Grant to City of Vallejo.	Approved. Ch. 117.
<u>S. 2082</u> (Kraft) Authorizes revised uses for tide and submerged lands granted to the City of Chula Vista by Ch. 120, Stats. 1925; Ch. 124, Stats. 1947; and Ch. 593, Stats. 1953.	Pocket vetoed.
<u>S. 2107</u> (Kraft) Transfers jurisdiction of Small Craft Harbor program to Department of Natural Resources.	Approved. Ch. 2362.
<u>S. 2110</u> (Kraft) Adds Sections 6499.5 and 6499.6, Public Resources Code, appropriating \$100,000 for loans to cities, counties, or districts for Small Craft Harbor development.	Approved. Ch. 2375.
<u>S. 2212</u> (Abshire) Authorizes study of means to accomplish salinity control and flood control in the Sacramento-San Joaquin delta and San Francisco bay area.	Approved. Ch. 2092.
<u>S. 2238</u> (H. Johnson) Appropriates \$30,000 to State Lands Commission for clearing stumps, snags and old pilings from Lake Tahoe.	Pocket vetoed.

MISCELLANEOUS 9. (CONTD.)

BILL NO., AUTHOR, AND ABSTRACT

STATUS

S. 2503 (Murdy)

Authorizes Orange County to exchange filled tidelands in Upper Bay of Newport Bay for adjoining privately owned lands to permit effective location of navigation projects, subject to approval by State Lands Commission.

Approved. Ch. 2044.

S. 2668 (Erhart)

Corrects legal description of tide and submerged lands granted to County of San Luis Obispo under Ch. 1076, Stats. 1947.

Approved. Ch. 1874.

S. 2669 (Brown)

Amends Section 23136 of Government Code to clarify the description of the common Inyo-San Bernardino County boundary.

Approved. Ch. 2382.

A.B. 32 (Lowrey)

Establishes a committee for the development of the California Public Outdoor Recreation Plan consisting of designated State officers, including the Executive Officer of the State Lands Commission. Appropriates \$100,000 for administration.

Approved. Ch. 2318.
(Appropriation reduced to \$50,000.)

A.B. 47 (Miller)

Amends Public Resources Code to authorize oil and gas leases on alternative bonus-royalty or royalty bid bases from a minimum of 16-2/3 percent.

Approved. Ch. 2166.

A.B. 80 (Miller)

Directs that the State Lands Commission require that any geological or geophysical survey permittee make available to the Commission all factual and physical exploration results, logs, and records resulting from exploration operations on State lands.

Approved. Ch. 1087.
(Adopted as urgency legislation. In effect July 2, 1957.)

A.B. 91 (Lindsay)

Appropriates \$500,000 annually from the State Lands Act Fund to the Division of Forestry for basic research field studies and operations with respect to activities under its jurisdiction.

Approved. Ch. 2405.
(Appropriation reduced to \$100,000.)

A.B. 323 (McCollister)

Conveys tide and submerged lands within the limits of the City of Sausalito to that City.

Approved. Ch. 791.

MISCELLANEOUS 9. (CONTD.)

BILL NO., AUTHOR, AND ABSTRACT

STATUS

A.B. 501 (Brown)

Revises provisions in the Public Resources Code relative to publication of notices by the State Lands Division to provide for uniformity in such publication by cross reference to the provisions in Sections 6060-6066, Government Code.

Approved. Ch. 357.

A.B. 678 (McCollister)

Conveys tide and submerged lands within the limits of the Bolinas Bay Harbor District, Marin County, to that District.

Approved. Ch. 800.

A.B. 930 (Grant)

Authorizes the City of Long Beach to enter into voluntary unit-operating agreements for development of granted tide and submerged lands in conjunction with adjoining privately owned lands.

Approved. Ch. 1151.

A.B. 1063 (Coolidge)

Amends Section 6816, Public Resources Code, to provide a consolidated State Beach and Park Fund as successor to the State Park Maintenance Fund, the State Beach Fund, and the State Park Fund.

Approved. Ch. 2127.

A.B. 1144 (Beaver)

Appropriates \$1,000,000 annually from State Lands Act Fund to the State Soil Conservation Commission for grants to Soil Conservation Districts.

Approved. Ch. 2406.
(Appropriation reduced to \$100,000.)

A.B. 1607 (Kelly)

Appropriates \$500,000 annually from State Lands Act Fund to the Division of Mines for experimental work in development of ores and mining processes.

Pocket vetoed.

A.B. 1784 (McMillan & Others)

Authorizes a loan of \$2,000,000 to the County of Los Angeles for the development of Marina del Rey small craft harbor.

Approved. Ch. 2305.

A.B. 1845 (Sumner)

Amends Section 35313 and adds Section 35313.1, Government Code, relating to annexation of territory by cities to require that when State-owned tide or submerged lands are to be annexed the value of such lands is to be determined by the State Lands Commission, subject to judicial review.

Approved. Ch. 1954.

MISCELLANEOUS 9. (CONTD.)

BILL NO., AUTHOR, AND ABSTRACT

STATUS

A.B. 1969 (Weinberger)

Corrects references in Public Resources Code required by establishment of Department of Water Resources in lieu of Division of Water Resources.

Approved. Ch. 1932.

A.B. 2073 (Brown)

Adds Section 6109, Public Resources Code, requiring meetings of State Lands Commission to be open to the public.

Approved. Ch. 2203.

A.B. 2423 (Coolidge)

Establishes \$10,000,000 Small Craft Harbor and Port of Refuge Financing Fund to be administered by the State Lands Commission through loans to local authorities.

Pocket vetoed.

A.B. 2618 (Cunningham)

Appropriates \$4,000,000 as a loan to the governing board of the Ventura Port District for the establishment of a small craft harbor.

Pocket vetoed.

A.B. 2678 (Schrade)

Grants tide and submerged lands in San Diego Bay to the City of Coronado.

Approved. Ch. 836.

A.B. 2925 (Shell)

Amends Section 6816, Public Resources Code, to increase maximum amount of annual transfer of money to State Beach and Park Funds from \$7,000,000 to \$12,000,000.

Approved. Ch. 2367.

A.B. 3038 (Hegland)

Provides for payment by the State of one-half of the cost of local cooperation in federal-beach-erosion-control projects and requires annual report on such projects by the Department of Water Resources. Approval of the report by the State Lands Commission is required when the erosion-control projects are included in a small-boat-harbor-development project.

Pocket vetoed.

A.B. 3071 (Chapel)

Appropriates \$500,000 annually for five fiscal years to the Small Craft Harbors Revolving Fund.

Approved. Ch. 2408.
(Appropriation reduced to \$40,000.)

A.B. 3153 (Grant; Clocksiem)

Provides for exercise of eminent domain in connection with the protection of land from surface subsidence.

Approved. Ch. 1395.

MISCELLANEOUS 9. (CONTD.)

BILL NO., AUTHOR, AND ABSTRACT

STATUS

A.B. 3540 (D. Doyle)

Clarifies legal description of tide and submerged lands granted to the City of Antioch under Ch. 1939, Stats. 1955.

Approved. Ch. 1430.

A.B. 3610 (Belotti)

Authorizes State Lands Commission to sell a small parcel of filled tideland in Humboldt County lying between a parcel of swamp and overflowed lands and a parcel of tidelands previously conveyed by the State.

Approved. Ch. 1437.

A.B. 3812 (O'Connell)

Authorizes State Lands Commission to exchange tide and submerged lands in Hunters Point Recreation District for other lands of equal value and provides for removal of the navigation trust when lands within the District are filled.

Approved. Ch. 1999.

A.B. 3813 (O'Connell)

Appropriates \$50,000 to State Lands Commission to accelerate determination of boundaries of granted tide and submerged lands in Long Beach and requires a progress report to the Legislature.

Approved. Ch. 2000.

A.B. 4078 (MacBride)

Authorizes investment of impounded tide and submerged lands rental and royalties which may accrue from lease operation in tide and submerged lands under title dispute.

Approved. Ch. 2006.

A.B. 4165 (MacBride)

Authorizes the State Lands Commission to sell Chain Island, San Joaquin River, Sacramento County.

Approved. Ch. 2012.
