THE EXECUTIVE OFFICER IS AUTHORIZED TO GRANT TO THE STANDARD OIL COMPANY OF CALIFORNIA, OPERATOR, A DEFERMENT OF DRILLING AND OPERATING REQUIREMENTS UNDER OIL AND GAS LEASE P.R.C. 1744.1 TO JUNE 14, 1958. (REQUEST FOR DEFERMENT OF DRILLING AND OPERATING REQUIREMENTS, STANDARD OIL COMPANY OF CALIFORNIA, SANTA BARBARA COUNTY - W. O. 2851.)

On March 10, 1958 (Minute Item 5, page 3879), the Commission granted to the Tidewater Oil Company a further deferment of drilling and operating requirements under Oil and Gas Lease P.R.C. 1744.1 to May 12, 1958 in order to permit the Tidewater Oil Company to complete arrangements which were then in the process for the drilling of a well into the leased area. A request has been received from the Standard Oil Company of California, the proposed operator under the partial assignment by the Tidewater Oil Company, for an additional extension of time to June 14,1958 in which to commence operations under the subject lease so that negotiations, which are still in process, for the drilling of a well may be completed and a well commenced within this extension period.
