After presentation of Calendar Item 8 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO WESTERN OFFSHORE DRILLING AND EXPLORATION CO. A GEOLOGICAL SURVEY PERMIT, CONFORMING TO THE OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION, FOR THE PERIOD MAY 13, 1958 TO AUGUST 12, 1958, INCLUSIVE, IN ORDER TO OBTAIN GEOLOGICAL INFORMATION BELOW THE SURFACE OF THE OCEAN FLOOR IN TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND A LINE DRAWN DUE SOUTH FROM A POINT ON THE ORDINARY HIGH WATER MARK SIX MILES EASTERLY OF POINT DUME, LOS ANGELES COUNTY, SUBJECT TO THE FOLLOWING CONDITIONS:

- 1. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS:
- 2. UPON DEMAND BY THE COMMISSION, THE PERMITTEE SHALL MAKE AVAILABLE FOR INSPECTION ALL FACTUAL AND PHYSICAL EXPLORATION RESULTS, LOGS, AND RECORDS RESULTING FROM THE OPERATIONS UNDER THE PERMIT, FOR THE CONFIDENTIAL INFORMATION OF THE COMMISSION.

(APPLICATION FOR A GEOLOGICAL SURVEY PERMIT, SAN LUIS OBISPO, SANTA BARBARA, VENTURA AND LOS ANGELES COUNTIES, WESTERN OFFSHORE DRILLING AND EXPLORATION CO. - W. O. 2898.)

An application has been received from the Western Offshore Drilling and Exploration Co. for permission to conduct geological explorations from mobile marine equipment for the three-month period commencing May 13, 1958 to August 12, 1958. Permission has been requested to conduct core drilling operations below the ocean floor in those tide and submerged lands under the jurisdiction of the Commission in the area lying between a line drawn due West from Point San Luis, San Luis Obispo County, and a line drawn due South from a point on the ordinary high water mark six miles easterly of Point Dume, Los Angeles County.

Western Offshore Drilling and Exploration Co., as operator, proposes to enter into contracts with independent operators for the conduct of core drilling operations. The statutory application filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO WESTERN OFFSHORE DRILLING AND EXPLORATION CO. A GEOLOGICAL SURVEY PERMIT, CONFORMING TO THE OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION, FOR THE PERIOD MAY 13, 1958 TO AUGUST 12, 1958, INCLUSIVE, IN ORDER TO OBTAIN GEOLOGICAL INFORMATION BELOW THE SURFACE OF THE OCEAN FLOOR IN TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND A LINE DRAWN DUE SOUTH FROM A POINT ON THE ORDINARY HIGH WATER MARK SIX MILES EASTERLY OF POINT DUME, LOS ANGELES COUNTY, SUBJECT TO THE FOLLOWING CONDITIONS:

- 1. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS;
- 2. UPON DEMAND BY THE COMMISSION, THE PERMITTEE SHALL MAKE AVAILABLE FOR INSPECTION ALL FACTUAL AND PHYSICAL EXPLORATION RESULTS, LOGS, AND RECORDS RESULTING FROM THE OPERATIONS UNDER THE PERMIT, FOR THE CONFIDENTIAL INFORMATION OF THE COMMISSION.
