An offer has been received from Louis Mattis of North Hollywood, California, to purchase the W_2^1 of NW_4^1 , W_2^1 of SW_4^1 , SE_4^1 of SW_4^1 , SE_4^1 , and N_2^1 of NE_4^1 of Section 16, T. 1 N., R. 24 E., S.B.M., containing 440 acres in San Bernardino County. The applicant made an offer of \$880, or \$2 per acre.

An appraisal report completed by a member of the Commission's staff under date of January 22, 1958 establishes the value of the W_2^1 of NW_4^1 , W_2^1 of SW_4^1 , SE_4^1 of SW_4^1 and SE_4^1 of Section 16, T. 1 N., R. 24 E., at \$5 per acre, and the value of the N_2^1 of NE_4^1 of Section 16, T. 1 N., R. 24 E., S.B.M., at \$7.75 per acre, for a total combined value of \$2,420. The appraisal shows that the land is not suitable for cultivation without artificial irrigation.

Before the land was advertised for sale, the applicant deposited the necessary amount to meet the total appraised value of \$2,420. The land was advertised for sale with a stipulation that bids must be in excess of the values stated above. No bids were received pursuant to advertising.

IT IS RECOMMENDED THAT THE COMMISSION FIND THAT THE W_2^1 OF NW_1^1 , W_2^1 OF SW_1^1 , SE_1^1 OF SW_1^1 , SE_1^1 AND N_2^1 OF NE_1^1 OF SECTION 16, T. 1 N., R. 24 E., S.B.M, CONTAINING 440 ACRES IN SAN BERNARDINO COUNTY, IS NOT SUITABLE FOR CULTIVATION WITHOUT ARTIFICIAL IRRIGATION, AND AUTHORIZE THE SALE OF SAID LAND TO THE SINGLE APPLICANT, LOUIS MATTIS, AT A TOTAL CASH PRICE OF \$2,420, SUBJECT TO ALL STATUTORY RESERVATIONS INCLUDING MINERALS.

Before the land was advertised for sale, the applicant deposited the necessary amount to meet the appraised value of \$3,157.50. The land was advertised for sale with a stipulation that bids must be in excess of \$5,157.50.

IT IS RECOMMENDED THAT THE COMMISSION FIND THAT ALL OF TRACT 55, T. 14 S., R. 1 E., S.B.M., AS SHOWN UPON THE OFFICIAL UNITED STATES PLAT OF "INDEPENDENT RESURVEY OF THE BOUNDARIES OF SECTIONS 25, 26, 27, 34, 35 AND 36, WITH TRACT SEGREGATIONS" ACCEPTED APRIL 17, 1939, EXCEPTING THEREFROM THOSE PORTIONS THEREOF DESCRIBED IN PATENTS ISSUED BY THE STATE OF CALIFORNIA ON JUNE 5, 1925 TO JAMES H. ST. CLAIR AND ON FEBRUARY 4, 1948 TO H. H. IT IS RECOMMENDED THAT THE COMMISSION FIND THAT SECTION 36, T. 31 S., R. 40 E., M.D.M., CONTAINING 640 ACRES IN KERN COUNTY, IS NOT SUITABLE FOR CULTIVATION WITHOUT ARTIFICIAL IRRIGATION, AND AUTHORIZE THE SALE OF SAID LAND TO THE SINGLE APPLICANT, FREDERICK R. STOWELL, AT A CASH PRICE OF \$57,600, SUBJECT TO ALL STATUTORY RESERVATIONS INCLUDING MINERALS.
