Lease P.R.C. 493.1 covering approximately 3.20 acres in Guadalupe Canal, San Mateo County, was issued to the Crocker Estate Company for a 15-year term from February 10, 1950 at an annual rental of \$558.39, and Lease P.R.C. 776.1 covering approximately 6.59 acres in Guadalupe Canal, San Mateo County, was issued to the Crocker Estate Company for a 15-year term from January 1, 1953 at an annual rental of \$1,320. Both leases contain a provision for their termination.

On June 11, 1958 (Minute Item 5, pages 4058-60) the Commission authorized the sale of the land included in Leases P.R.C. 493.1 and P.R.C. 776.1 to the lessee, Crocker Estate Company. To perfect the title to the land being sold, these two leases should be cancelled on the effective date of the conveyance (patent) and the uncarned portion of the current year's rental should be refunded in accordance with established policy.
