

MINUTE ITEM

12. (ASSIGNMENT OF PARTIAL INTEREST, OIL AND GAS LEASE P.R.C. 2205.1, PAULEY CALIFORNIA TIDELANDS, INC., SANTA BARBARA COUNTY - W. O. 3041(B).)

After presentation of Calendar Item 26 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE THE ASSIGNMENT OF A PARTIAL INTEREST IN STATE OIL AND GAS LEASE P.R.C. 2205.1 FROM PAULEY CALIFORNIA TIDELANDS, INC., TO EDWIN W. PAULEY, AN INDIVIDUAL, SUBJECT TO SUBMISSION OF PROPER BOND BY THE ASSIGNEE. THE ASSIGNEE IS TO BE BOUND BY THE TERMS OF THE LEASE TO THE SAME EXTENT AS THE ORIGINAL LESSEE.

(ASSIGNMENT OF PARTIAL INTEREST, OIL AND GAS LEASE P.R.C. 2205.1, PAULEY CALIFORNIA TIDELANDS, INC., SANTA BARBARA COUNTY - W. O. 3041(B).)

On July 25, 1958 Oil and Gas Lease P.R.C. 2205.1 was issued to Phillips Petroleum Company, Edwin W. Pauley, et al. (see Exhibit "A" attached to Calendar Item 9 for complete list of bidders), joint bidders, pursuant to competitive public bidding in accordance with Division 6 of the Public Resources Code.

An application has been received from Pauley California Tidelands, Inc., a joint lessee, for the assignment of its interest in Lease P.R.C. 2205.1 to Edwin W. Pauley, an individual.

Section 4 of the lease provides for the assignment as to either a divided or undivided interest in the lease with the approval of the State to an individual who at the time of the proposed assignment possesses the qualifications required by the Public Resources Code. Edwin W. Pauley, an individual, has submitted evidence showing that he possesses qualifications necessary to satisfy the statutory requirements. The bond obligations required by the lease will have to be met by the assignee. A form of assignment has been executed by Pauley California Tidelands, Inc., assignor, and Edwin W. Pauley, an individual, assignee. The \$5 statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO APPROVE THE ASSIGNMENT OF A PARTIAL INTEREST IN STATE OIL AND GAS LEASE P.R.C. 2205.1 FROM PAULEY CALIFORNIA TIDELANDS, INC., TO EDWIN W. PAULEY, AN INDIVIDUAL, SUBJECT TO SUBMISSION OF PROPER BOND BY THE ASSIGNEE. THE ASSIGNEE IS TO BE BOUND BY THE TERMS OF THE LEASE TO THE SAME EXTENT AS THE ORIGINAL LESSEE.
