On July 25, 1958, State Oil and Gas Lease P.R.C. 2205.1 was issued to Phillips Petroleum Company, Edwin W. Pauley, The Tecolote Company, et al., joint bidders, pursuant to competitive bidding in accordance with Division 6 of the Public Resources Code.

An application has been received from The Tecolote Company, a Nebraska corporation, a joint lessee, for the assignment of its interest in Lease P.R.C. 2205.1 to a joint venture comprising -
