APPLICATION FOR 49-YEAR USE PERMIT, TIDE AND SUBMERGED LANDS IN PITTSBURG, CONTRA COSTA COUNTY, CALIFORNIA, CITY OF PITTSBURG - W.O. 3413.

An application has been received from the City of Pittsburg for a use permit for 49 years over 6.72 acres of tide and submerged lands in Pittsburg, north of Hooper Drive and between the lines of Cutter Avenue and Montezuma Street, extended, for use as a boat marina to be operated by municipal employees. The City has applied to the Small Craft Harbors Commission for a construction loan.

The issuance of a permit to the City as sole permittee is considered preferable to a lease as any rights conferred by the State would not be transferable. In the event that the boat marina were to be turned over to private operators, a lease would have to be negotiated with the State lands Commission.

No fees are to be charged.
