

MINUTE ITEM

15. APPLICATION FOR APPROVAL OF RIGHT-OF-WAY EASEMENT ACROSS TIDE AND SUEMERGED LANDS OF ROARING RIVER SLOUGH, SOLANO COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4043, P.R.C. 2804.1.

After consideration of Calendar Item 18 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASEMENT TO PACIFIC GAS AND ELECTRIC COMPANY, THE TOTAL CONSIDERATION IN THE AMOUNT OF \$195.02 TO BE PAYABLE IN ADVANCE, COVERING PROPERTY DESCRIBED AS FOLLOWS:

THAT CERTAIN STRIP OF TIDE AND SUEMERGED LAND 20 FEET IN WIDTH AND 182 FEET LONG, LYING AND BEING 10 FEET ON EITHER SIDE OF A CENTER LINE WHICH BEARS S. 2° 05' W.. ACROSS ROARING RIVER, SOLANO COUNTY, AS SHOWN ON DRAWING GE-34057-2 DATED SEPTEMBER 9, 1946, AS FILED BY THE PACIFIC PUBLIC SERVICE COMPANY.

APPLICATION FOR APPROVAL OF RIGHT-OF-WAY EASEMENT ACROSS TIDE AND SUBMERGED LANDS OF ROARING RIVER SLOUGH, SOLANO COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4043.

An application has been received from Pacific Gas and Electric Company for approval of a right-of-way easement for the operation and maintenance of an existing gas transmission line across tide and submerged lands of Roaring River Slough, Solano County, about 4 miles north of Pittsburg (see Exhibit "A" attached to Calendar Item No. 17). The easement lease replaces Lease P.R.C. 247.1, which expired August 21, 1961.

At the applicant's request, the new easement is to be limited to 20 feet in width, and is to be 182 feet long, containing .084 acre. The estimated value of the land is \$500 per acre. The calculated rental for a 49-year term is \$195.02.

No performance bond is required, as the installation would not adversely affect public use of the site for navigation and fishing, and the salvage value is such as to insure its removal.
