APPLICATION FOR RIGHT-OF-WAY EASEMENT OVER SUBMERGED LANDS OF CLEAR LAKE IN LAKE COUNTY, STATE DIVISION OF HIGHWAYS - W.O. 4271.

An application has been received from the State Division of Highways, pursuant to Section 101.5 of the Streets and Highways Code, for the use for right-of-way purposes of 1.6 acres more or less of submerged land comprising portions of Clear Lake in Section 36 of T. 15 N., R. 9 W., M.D.M., in Lake County, to provide for the protection, construction and use of State Highway Route I-Lak-15-B.

All of Clear Lake is under lease to the County of Lake. The County Administrative Officer has reported that the County has no objection to the issuance of this easement. However, the statement of nonobjection is not a waiver of the local body's right to attempt to negotiate a possible rerouting of the proposed highway with the State Division of Highways.
