9. APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER SUBMERGED LAND IN THIS AMERICAN RIVER AT CARMICHAEL, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 4261, P.R.C. 2847.9.

After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

PURSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12803, THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF A POWER LINE OVER THE FOLLOWING-DESCRIBED PARCEL OF SUBMERGED LANDS OF THE AMERICAN RIVER, SITUATE IN SACRAMENTO COUNTY:

WITHIN A STRIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET, THE CENTERLINE OF WHICH IS DESCRIBED AS FOLLOWS:

BECIMNING AT A POINT ON THE MEAN LOW WATER LINE ALONG THE SOUTH-EASTERLY BANK OF THE AMERICAN RIVER, FROM WHICH POINT THE NORTH-WESTERLY CORNEP OF THAT CENTAIN 7.346 ACRE TRACT DESIGNATED "SACRAMENTO COUNTY COLOMA TREATMENT PLANT", AS SAID TRACT IS SHOWN ON THAT CERTAIN RECORD OF SURVEY ENTITLED "PORTION OF SUBDIVISION G.M.G. TITUS 164-13/100 A RANCHO RIO DE LOS AMERICANOS", RECORDED IN THE OFFICE OF THE BECCRIER OF SACRAMENTO COUNTY ON MARCH 23, 1961, IN BOOK 17 OF SURVEYS, MAP NO. 37, BEARS SOUTH 3° 44' 11" EAST 1010.78 FEET DISTANT; THENCE, FROM SAID POINT OF BEGINNING NORTH 6° 56' 03" WEST 340.68 FLET TO A FOINT ON THE MEAN LOW WATER LINE ALONG THE NORTHWESTERLY BANK OF THE AMERICAN RIVER, CONTAINING 0.08 ACRE MORE OR LESS.

APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER SUBMERGED LAND IN THE AMERICAN RIVER AT CARMICHAEL, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 4261.

The Sacramento Municipal Utility District has applied for a right-of-way easement to construct a 12 KV power line across the American River near the end of Kenneth Avenue in Curmichael, California (see Exhibit "A"). This line will the together two existing power lines to provide better service to the County of Sacramento Treatment Plant. Public Utilities Code Section 12808 provides as follows:

"A district may construct works across or along any street or public highway, or over any of the lands which are the property of the State, and it shall have the same rights and privileges appartaining thereto as are granted to municipalities within the State. The district shall restore any such street or highway to its former state as near as may be, and in compliance with local ordinances, and shall not use it in a manner to unnecessarily impair its usefulness. A district may also construct its works across any stream or watercourse."

IT IS RECOMMENDED THAT, PLRSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12808, THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF A POWER LINE OVER THE FOLLOWING-DESCRIBED PARCEL OF SUBMERGED LANDS OF THE AMERICAN RIVER, SITUATE IN SACRAMENTO COUNTY:

TITUS 164-13/100 A RANCHO RIO DE LOS AMEPICANOS", RECORDED IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON MARCH 23, 2961, IN BOOK 17 OF SURVEYS, MAP NO. 37, BEARS SOUTH 3° 44' 11" EAST 1010.78 FEET DISTANT; THENCE, FROM SAID FOINT OF BEGINNING NORTH 6° 56' 03" WEST 340.68 FEET TO A POINT ON THE MEAN LOW WATER LINE ALONG THE NORTHWESTERLY BANK OF THE AMERICAN RIVER, CONTAINING 0.08 ACRE MCRE OR LESS.
