MINUTE ITEM

27. APPLICATION FOR LEASE OF 5.43 ACRES OF TIDE AND SUBMERGED LANDS IN OLD CHANNEL, SAN JOAQUIN RIVER, ADJOINING VULCAN ISLAND, SAN JOAQUIN COUNTY; GEORGE SPECIMAN - W.O. 4129, P.R.C. 2856.1.

After consideration of Calendar Item 18 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO GEORGE SPECKMAN A 15-YEAR LEASE COVERING 5.43 ACRES OF TIDE AND SUBMERGED LAND FOR THE PURPOSE OF OPERATING AND MAINTAINING A SMALL-BOAT HARBOR AND BERTHING FACILITIES AND A RECREATIONAL AREA. THE LEASE IS TO PROVIDE FOR:

- 1. LAND RENTAL OF \$681.86 ANNUALLY, THE FIRST AND LAST YEARS' RENTAL PAYABLE IN ADVANCE;
- 2. TWO RENEWAL PERIODS OF TEN YEARS EACH UPON SUCH REASONABLE TERMS AND CONDITIONS AS THE COMMISSION MAY THEN IMPOSE;
- 3. A RESERVATION UNTO THE STATE OF A PCYER-LINE RIGHT-OF-WAY LEASED TO THE PACIFIC GAS AND ELECTRIC COMPANY, LEASE F.R.C. 2474.1, LYING WITHIN THE AREA TO BE LEASED TO GEORGE SPECEMAN;
- 4. A SURETY BOND FOR \$1,000 IN FAVOR OF THE STATE OF CALIFORNIA DURING THE LEASE TERM.

APPLICATION FOR LEASE OF 5.43 ACRES OF TIDE AND SUBMERGED LANDS IN OLD CHANNEL, SAN JOAQUIN RIVER, ADJOINING VULCAN IS AND, SAN JOAQUIN COUNTY; GEORGE SPECKMAN - W.O. 4129.

An application has been received from George Spackman for a lease of 5.43 acres of tide and submerged lands adjoining Vulcan Island (see Exhibit "A"). The scel is located approximately 4.5 air-line miles northwest of the City of Stockton in the old channel of the San Joaquin River, San Joaquin County. The applicant plans to use the area for small-boat-harbor and berthing facilities as well as for an accessory facility to the restaurant and recreational area now on Vulcan Island.

Based upon a starf appraisal and a field investigation, the land rental for a 15-year period would be at the rate of \$681.86 per year, the lease to contain the following conditions:

- 1. Rirst and last years' rental payable in advance.
- 2. Two renewal periods of ten years each upon such reasonable terms and conditions as the State Lands Commission may then impose.
- 3. A \$1,000 Surety Bond in favor of the State during the life of the lease.
- 4. A reservation to the State of the Facific Gas and Electric power-line right-of-way, Lease P.F.C. 2474.1.

The statutory filing fee and expense deposit have been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO GEORGE SPECKMAN A LEASE COVERING 5.43 ACRES OF TIDE AND SUBMERGED LAND FOR THE PURPOSE OF OPERATING AND MAINTAINING A SMALL-BOAT-HARBOR AND BERTHING FACILITIES AND A RECREATIONAL AREA. THE LEASE IS TO PROVIDE FOR:
