After consideration of Calendar Item 12 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A TEN-YEAR RENEWAL OF LEASE P.R.C. 245.1, COVERING CERTAIN TIDE AND SUBMERGED LANDS OF NEW YORK SLOUGH, CONTRA COSTA COUNTY, TO THE THERMOID DIVISION, H. K. PORTER COMPANY, INC. THE RENEWAL LEASE IS TO HAVE AN EFFECTIVE DATE OF AUGUST 22, 1961, AND IS TO PROVIDE FOR AN ANNUAL RENTAL OF \$793.80. APPLICATION FOR RENEWAL OF LEASE P.R.C. 245.1; TIDE AND SUBMERGED LANDS OF NEW YORK, SLOUGH, CONTRA COSTA COUNTY; H. K. PORTER COMPANY, INC., THERMOID DIVISION - W.O. 4082.

Lease P.R.C. 245.1 was issued to Pioneer Rubber Mills for an initial period of 15 years beginning August 22, 1946. The lease contained a renewal option of one period of ten years. The Thermoid Division of H. K. Forter Company, Inc., successor in interest to the original lessee by assignment approved by the State Lands Commission on April 8, 1957, made application for the tenyear renewal prior to expiration of the lease. The lease area, comprising 2.1 acres of tide and submerged lands fronting on the southerly side of New York Slough at Pittsburg, Contra Costa County, is used for vater intake and discharge lines and for a general storage area (see Exhibit "A"). The rental under the expired lease was \$199.98 per year. A staff appreciaal of the site, made is connection with the renewal application, has established the current value of the parcel at \$12,600. Therefore, the present value of the lands justifies on increase in rental to \$793.80 per year.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A TEM-YEAR RENEWAL OF LEASE P.R.C. 245.1, COVERING CERTAIN TIDE AND SUBMERGED LANDS OF NEW YORK SLOUGH, CONTRA COSTA COUNTY, TO THE THERMOID DIVISION, H.
