7. APPLICATION FOR DREDGING PERMIT, BODEGA BAY, SONOMA COUNTY; RAY SHAW - W.O. 3942, P.R.C. 2885.9.

After consideration of Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO RAY SHAW, WITHOUT THE PAYMENT OF ROYALTY (THE CONSIDERATION BEING THE FUBLIC BENEFIT ARISING FROM THE IMPROVEMENT OF NAVIGATION), AUTHORIZING THE DREDGING OF APPROXI-MATELY 69,882 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED AREA OF TIDE AND SUEMERGED LANDS GRANTED TO THE COUNTY OF SONOMA:

APPLICATION FOR DREDGING PERMIT, BODEGA BAY, SONOMA COUNTY; RAY STAN - W.O. 3942.

An application has been received from Ray Shaw for a permit to dredge in Bodega Bay, Sonoma County, for the purpose of removing an estimated 69,882 cubic yards of material to form a two-basin marina with approach channels. The dredged material will be deposited on granted land areas to form a site for servicing the marina. The County of Sonom., to which the tide and submerged lands in Bodega Bay were granted 1. 1959 (Ch. 1064, Stats. 1959), entered into a lease with Ray Shaw on January 10, 1961, for the area to be used for the marina project.

By the terms of the granting statute and amendments the sto, minerals in Bodega Bay were reserved to the State; i.e., "There is hereby excepted and reserved to the State of California all deposits of minerals, including oil and gas, in said lands, and to the State of California, or persons authorized by the State of California, the right to prospect for, mine and remove such deposits from said land."

The United States Corps of Engineers has issued a Department of the Army permit to the applicant authorizing the proposed dredging operation; the Division of Small Craft Barbors has reported that the proposed marine does not conflict with any small-craft merbor projects; the Department of Natural Resources (Conservation Department) has reported that the proposed dredging operations will not interfere with the recreational use of Lends littoral to the tide or submerged Lands involved in the application; the County of Sonoma considers this project beneficial to the development of Eodega Bay.

The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A FERMIT TO RAY SHAW, WITHOUT THE PAYMENT OF ROYALTY, (THE CONSIDERA-TION BEING THE PUBLIC BENEFIT ARISING FROM THE IMPFOVEMENT OF NAVIGATION), AUTHORIZING THE DREDGING OF APPROXIMATELY 69,882 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED AREA OF TIDE AND SUBMERGED LANDS GRANTED TO THE COUNTY OF SONOMA:
