## MINUTE ITEM

8. APPLICATION FOR PERMIT TO CONSTRUCT PUBLIC FISHING ACCESS, INCLUDING BOAT-LAUNCHING RAMP, SUBMERGED LANDS, SACRAMENTO RIVER, SOLANO COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 4344, P.R.C. 2886.9.

After consideration of Calendar Item 22 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR PERMIT TO THE DEPARTMENT OF FISH AND GAME, STATE OF CALIFORNIA, FOR A PUBLIC FISHING ACCESS WHICH IS TO INCLUDE A BOAT-LAUNCHING RAMP, IN AN AREA DESCRIBED AS FOLLOWS:

A PARCEL OF TIDE AND SUBMERGED LAND IN THE BED OF THE SACRAMENTO RIVER AT RIV VISTA, SOLANO COUNTY, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BECINNING AT THE INTERSECTION OF THE SOUTHWEST LINE OF MAIN STREET WITH THE SOUTHEAST LINE OF FRONT STREET IN THE CITY OF RIO VISTA; THENCE S. 45° 00' E., 296.14 FEET; THENCE S. 45° 00' W., 100.00 FEET; THENCE S. 45° 00' E., 187 FEET MORE OR LESS TO THE MEAN HIGH TIDE LINE ALONG THE RIGHT BANK OF THE SACRAMENTO RIVER, BEING THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL; THENCE FROM SAID TRUE POINT OF BEGINNING, S. 45° 00' E., 125.0 FEET; THENCE S. 36° 10' W., 74 FEET MORE OR LESS TO A LINE WHICH BEARS S. 72° 55' E. AND PASSES THROUGH THE MOST EASTERLY CORNER OF LOT 16 AS SHOWN UPON THE MAP ENTITLED "MAP OF RIVERSIDE, CITY OF RIO VISTA, SOLANO COUNTY, CALLWORNIA" FILED IN BOOK 17 OF MAPS, PAGE 70, SOLANO COUNTY RECORDS; THENCE ALONG SAIT: LINE N. 72° 55' W., 73 FEET MORE OR LESS TO THE MEAN HIGH TIDE LINE; THENCE MORTH-EASTERLY ALONG SAID LINE 130 FEET MORE OR LESS TO THE TRUE POINT OF BEGINNING, AND CONTRINING Q.212 ACRE MORE OR LESS.

APPLICATION FOR PERMIT TO CONSTRUCT PUBLIC FISHING ACCESS, INCLUDING BOALL-LAUNCHING RAMP, SUBMERGED LANDS, SACRAMENTO RIVER, SOLANO COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 4344.

The Department of Fish and Game proposes to construct a public fishing access facility, portions of which will occupy submerged lands of the Sacramento River in the City of Rio Vista, Solano County (see Exhibit "A"). The over-all project will include a parking area, restroom facilities, and a boat-launching ramp, the latter structure to be on State land.

IT IS RECOMMED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A 49-YEAR PERMIT TO THE DEPARTMENT OF FISH AND GAME, STATE OF CALIFORNIA, FOR A PUBLIC FISHING ACCESS WHICH IS TO INCLUDE A BOAT-LAUNCHING RAMP, IN AN AREA DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE SOUTHWEST LINE OF MAIN STREET VITH THE SOUTHEAST LINE OF FRONT STREET IN THE CITY OF RIO VISTA; THENCE S. 45° 00' E., 296.14 FEET; THENCE S. 45° 00' W., 100.00 FEET; THENCE S. 45° 00' E., 187 FEET MORE OR LESS TO THE MEAN HIGH TIDE LINE ALONG THE RICHT BANK OF THE SACRAMENTO RIVER, BEILT THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED PARCEL; THENCE FROM SAID TRUE POINT OF BEGINNING, S. 45° 00' E., 125.0 FEET; THENCE S. 36° 10' W., 74 FEET MORE OR LESS TO A LINE WHICH BEARS S. 72° 55' E. AND PASSES THROUGH THE MOST EASTERLY CORNER OF LOT 16 AS SHOWN UPON THE MAP FUTITIED "MAP OF RIVERSIDE, CITY OF RIO VISTA, SOLANO COUNTY, CALIFORNIA" FILED IN EOOK 17 OF MAPS, PAGE 70, SOLANO COUNTY RECORDS; THENCE ALONG SAID LINE N. 72° 55' W., 73 FEET MORE OR LESS TO THE MEAN HIGH TIDE LINE; THENCE NORTHEAST. "Y ALONG SAID LINE 130 FEET MORE OR LESS TO THE TRUE POINT OF BEGINNIN', AND CONTAINING 0.212 ACRE MORE OR LESS.
