Beloil Corporation, Ltd., lessee of a partial interest under Essement No. 275, which was issued on March 1, 1934, and extended and renewed on March 1, 1954, under State Oil and Gas Lease Extension and Kenewal P.R.C. 920.1, for a period of 10 years and for so long thereafter as oil or sas is produced in paying quantities, has submitted an application for the assignment of all of its interest in Lease.P.R.C. 320.1 to Hundle Oil & Refining Company, a present joint lessee.

The drilled course of the wells operating under Lease P.R.C. 920.1 traverses uplands under jurisdiction of the Huntington Reach Townsite Association.
