After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 6 CF THE PUBLIC RESOURCES CODE, THE COMMISSION ACCEPTS THE HIGHEST QUALIFIED BIL, MADE BY SHELL OIL COMPANY AND STANDARD OIL COMPANY OF CALIFORNIA ON AUGUST 9, 1962, AND AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE AN OIL-AND-GAS LEASE TO THE SAID JOINT BIDDERS FOR THE 4,250.14-ACRE PARCEL OF TIDE AND SUBMERGED LANDS DESIGNATED AS W.O. 4480 (PARCEL 8A), P.R.C. 2920.1 IN SANTA BARBARA COUNTY, AS DETAILED IN THE PUBLISHED NOTICE OF INTENTION UNDER W.O. 4480 (PARCEL 8A) PUBLISHED JULY 20 AND JULY 25, 1962. ACCEPIANCE OF BID AND AWARD OF SIL AND GAS LEASE, TIDE AND SUBMERGED LANDS, SANTA BARBARA COUNTY - W.O. 4480 (PARCEL 8A), P.R.C. 2920.1.

On August 9, 1962, four bids were received in response to a published Notice of Intention of the State Lands Commission to enter into a lease for the extraction of oil and gas from 4,250.14 acres of tide and subserged lands, designated as W.O. 4480 (Parcel 8A), Santa Barbara County. This offer was authorized by the Commission on July 19, 1962.

All bids submitted were reviewed by the staff as to technical sufficiency and economic factors. The office of the Attorney General reviewed the highest bid, submitted by Shell Oil Company and Standard Oil Company of California, and determined:

- A. That the Commission has complied with the procedural requirements of law; and
- B. That the bid submitted conforms with:
 - 1. The bid requirements specified in the proposal of the Commission;
 - 2. The applicable provisions of law; and
 - 3. The rules and regulations of the Commission.

A summary of the cash bonus-payment offers received pursuant to the lease proposal is attached.
