## MINUTE ITEM

6. APPLICATION FOR AMENDMENT OF THE AMENDED LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 1364.9, TIDE AND SUBMERGED LANDS OF THE PACIFIC OCEAN IN CITY AND COUNTY OF SAN FRANCISCO; NORTH SAN MATEO SANITATION DISTRICT -W.O. 4583.

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO DELETE THE LEGAL DESCRIPTION CONTAINED IN THE AMENDMENT OF APRIL 26, 1962, OF LEASE P.R.C. 1364.9, AND TO SUBSTITUTE THE FOLLOWING DESCRIPTION IN LIEU THEREOF:

A STRIP OF LAND 100 FEET IN WIDTH, LYING 50 FEET ON EACH SIDE OF A CENTERLINE EXTENDING S. 87° 22' 37" W., 2500 FEET SEAWARD OF THE MEAN HIGH WATER LINE OF THE PACIFIC OCEAN, FROM A POINT (A) ON SAID MEAN HIGH WATER LINE WHICH BEARS S. 87° 22' 37" W., 90 FEET MORE OR LESS, FROM A POINT (B) ON THE WESTERLY LINE OF THE LANDS OF THE UNITED STATES OF AMERICA, VETERANS ATMINISTRATION, WHICH IS THE POINT OF INTERSECTION OF SAID WESTERLY LINE WITH THE CENTERLINE OF THAT CERTAIN DRAINAGE EASTMENT DESCRIBED IN DEED RECORDED AUGUST 7, 1917, IN BOOK 1028 OF DEEDS, PAGE 119, OFFICIAL RECORDS OF THE CITY AND COUNTY OF SAN FRANCISCO, SAID POINT (B) ALSO BEARING N. 16° 31' 07" W., 1241.20 FEET, FROM THE MOST SOUTHERLY CORNER OF SAID LANDS OF THE UNITED STATES OF AMERICA, CONTAINING 5.739 ACRES MORE OR LESS, IN THE CITY AND COUNTY OF SAN FRANCISCO.

ALL OTHER CONDITIONS OF PERMIT P.R.C. 1364.9 ARE TO REMAIN IN FULL FORCE AND EFFECT.

APPLICATION FOR AMENDMENT OF THE AMENDED LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C.1364.9, TIDE AND SUBMERGED LANDS OF THE PACIFIC OCEAN IN CITY AND COUNTY OF SAN FRANCISCO; NORTH SAN MATEO SANITATION DISTRICT - W.O. 4583.

Life-of-Structure Permit P.R.C. 1364.9, which was issued on April 24, 1954, for the construction, maintenance and operation of a sewer outfall, was amended on April 26, 1962, by the State Lands Commission at the request of the County Sanitation District in order to meet the requirements of the State Water Pollution Control Board, the amendment providing for a 1500-foot extension of the existing right-of-way. The County has since advised that the amended area will not suffice for the requirements of the State Water Pollution Control Board, and is now requesting an extension of 2500 feet in lieu of the extension as formerly granted.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO DELETE THE LEGAL DESCRIPTION CONTAINED IN THE AMENDMENT OF APRIL 26, 1962, OF LEASE P.R.C. 1364.9, AND TO SUBSTITUTE THE FOLLOWING DESCRIPTION IN LIEU THEREOF:

A STRIP OF LAND 100 FEET IN WIDTH, LYING 50 FEET ON EACH SIDE OF A CENTERLINE EXTENDING S. 87° 22' 37" W., 2500 FEET SEAVAKD OF THE MEAN HIGH WATER LINE OF THE PACIFIC OCEAN, FROM A POINT (A) ON SAID MEAN HIGH WATER LINE WHICH BEARS S. 87° 22' 37" W., 90 FEET MORE OR LESS, FROM A POINT (b) ON THE WESTERLY LINE OF THE LANDS OF THE UNITED STATES OF AMERICA, VETERANS ADMINISTRATION, WHICH IS THE POINT OF INTERSECTION OF SAID WESTERLY LINE WITH THE CENTERLINE OF THAT CERTAIN DRAINAGE EASEMENT DESCRIBED IN DEED RECORDED AUGUST 7, 1917, IN BOOK 1028 OF DEEDS, PAGE 119, OFFICIAL RECORDS OF THE CITY AND COUNTY OF SAN FRANCISCO, SAID POINT (B) ALSO BEARING N. 16° 31' 07" W., 1241.20 FEET, FROM THE MOST SOUTHERLY CORNER OF SAID LANDS OF THE UNITED STATES OF AMERICA, CONTAINING 5.739 ACRES MORE OR LESS, IN THE CITY AND COUNTY OF SAN FRANCISCO.

ALL OTHER CONDITIONS OF PERMIT P.R.C. 1364.9 ARE TO REMAIN IN FULL FORCE AND EFFECT.
