After consideration of Calendar Item 2 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE COUNTY OF STANISLAUS A 49-YEAR BRIDGE EASEMENT OVER:

A STRIP OF LAND 200 FEET WIDE ACROSS THE BED OF THE TUOLUMNE RIVER IN SECTION 33, T. 3 S., R. 11 E., M.D.M., STANISLAUS COUNTY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID SECTION 33, THENCE N. 0° 55' W. ALONG THE EAST LINE THEREOF, 1,836.62 FEET; THENCE N. 18° 27' 16" W., 2,608 FEET MORE OR LESS TO THE LOW WATER MARK ALONG THE LEFT BANK OF THE TUOLUMNE RIVER, BEING THE TRUE POINT OF EEGINNING OF THE HEREIN DESCRIBED CENTERLINE; THENCE CONTINU-ING N. 18° 27' 16" W., 308 FEET MORE OR LESS TO THE LOW WATER MARK ALONG THE RIGHT BANK OF THE TUOLUMNE RIVER, CONTAINING 1.41 ACRES MORE OR LESS.

THE CONSIDERATION FOR THE EASEMENT IS TO BE THE PURLIC USE AND BENEFIT.

APPLICATION FOR 49-YEAR BRIDGE EASEMENT OVER TIDE AND SUEMERGED LANDS OF TUOLULARE RIVER, STANISLAUS COUNTY; COUNTY OF STANISLAUS, DEPARTMENT OF PUPLIC WORKS - W.O. 4488.

The County of Stanislaus, Department of Public Works, has applied for a 49-year bridge easement covering 1.41 acres more or less of tide and submerged lands of the Tuolumne River near the town of Waterford, Stanislaus County (see Exhibit "A").

The easement is to be for the construction, maintenance and use of a bridge which is to be built by Stanislaus County and the Federal government, acting through the State of California's Department of Public Works. This bridge project is in connection with the relocation of certain roads in the area.

The consideration for the easement is to be the public use and benefit.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE COUNTY OF STANISLAUS A 49-YEAP. BRIDGE EASEMENT OVER:

A STRIP OF LAND 200 FEET WILE ACROSS THE BED OF THE TUOLUMANE RIVER IN SECTION 33, T. 3 S., R. 11 E., M.D.M., STATISLAUS COUNTY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF SAID SECTION 33, THENCE N. 0° 55' W. ALONG THE EAST LINE TELEFOF, 1,836.62 FEET; THENCE N. 18° 27' 16" W., 2,608 FEET MORE OR LESS TO THE LOW WATER MARK ALONG THE LEFT BANK OF THE TUOLUMNE RIVER, BEING THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED CENTERLINE; THENCE CONTINU-ING N. 18° 27' 16" W., 308 FEET MORE OR LESS TO THE LOW WATER MARK ALONG THE RIGHT BANK OF THE TUOLUMNE RIVER. CONTAINING 1.41 ACRES MORE OR LESS.
