10. APPLICATION FOR PERMIT TO MAKE TEST BORINGS ON STATE SOVEREIGN LAND OF OWENS LAKE, INYO COUNTY; U. S. ARMY CORPS OF ENGINEERS - W.O. 4513, P.R.C. 2962.9.

APPLICATION FOR PERMIT TO MAKE TEST BORINGS ON STATE SOVEREIGN LAND OF OWENS LAKE, INYO COUNTY; U. S. ARMY CORPS OF ENGINEERS - W.O. 4513.

The U. S. Army Corps of Engineers has applied for a permit to make test borings on State sovereign lands of Owens Lake, Inyo County (see Exhibit "A").

Necessary drilling equipment is to be landed on the site by means of small planes. Each of the tests, which are to be made for the purpose of analyzing soil characteristics, will take from three to four days, after which the land will be restored to its natural condition, and a copy of the test reports will be furnished to the State. The drilling operations are to be conducted only on unleased portions of the lake bed, and all drilling will be in compliance with all rules and regulations now promulgated by any agency of the State of California having jurisdiction therein.

The permit is to be for one year. The permit consideration will be the interests of national defense and the furnishing to the Commission of a copy of the test report.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE U. S. ARMY CORPS OF ENGINEERS A ONE-YEAR PERMIT TO MAKE TEST BORINGS ON UNLEASED SOVEREIGN STATE LANDS OF OWENS LAKE DESCRIBED AS:
