APPROVAL OF AMENDMENT TO LEASE P.R.C. 2856.1, OLD CHANNEL OF SAN JOAQUIN RIVER, SAN JOAQUIN COUNTY; GEORGE SPECKMAN - W.O. 4584.

Application has been received from Mr. George Speckman for amendment of the description of the 5.43 acres of tide and submerged lands now embraced in Lease P.R.C. 2856.1, issued to Mr. Speckman for a 15-year term beginning February 27, 1962 (Commission meeting of February 27, 1962, pages 7718-21). This emendment is required in the event of Commission approval of a proposal to exchange a 0.37-acre portion of the area now under lease for a 0.37-acre portion of adjacent Vulcan Island owned by Mr. Speckman, as recommended in S.W.O. 7534 (Calendar Item 23) of this agenda. The consummation of the foregoing transaction will result in some of the area now leased becoming lands of the lessee and some lands now owned by the lessee becoming sovereign lands, subject to lease. Since the parcels proposed to be substituted have the same acreage and value, there will be no change in the total acreage or the annual rental.

IT IS RECOMMENDED THAT, IF THE EXCHANGE PROPOSAL SUBMITTED ON THIS AGENDA UNDER S.W.O. 7934 (CALENDAR ITEM 23) IS AUTHORIZED BY THE COMMISSION AND CONSUMMATED, THE EXECUTIVE OFFICER BE AUTHORIZED TO AMEND LEASE P.R.C. 2856.1 TO DELETE THE O.37 ACRI WHICH IS NO LONGER OWNED BY THE STATE (AS DESCRIBED IN EXHIBIT "A"), AND TO ADD AND INCLUDE THE O.37 ACRI ACQUIRED BY THE STATE (AS DESCRIBED IN EXHIBIT "B").
