Willis H. and Marjorie D. Polley have applied for a lease covering Lot 18 of the Fish Canyon cabin sites on State school land north of Duarte, Los Angeles County (see Exhibit "A" following Calendar Item 18), to replace Lease P.R.C. 1277.2, covering this site, which expired December 31, 1962, and which was held by Roy Robertson, Asa T. Tinnell, and Fred G. Hasenmair.

Fish Canyon is located in the San Gabriel mountain foothills, north of the City of Duarte, in Los Angeles County, 25 miles from Los Angeles Civic Center; it is a primitive area accessible only on foot.

The lease is to be for a term of 10 years, at an annual rental of \$65 per year, this term and rental having been approved by Commission action for Fish Canyon cabin site leases; the first and last years rentals will be payable in advance.
