13. APPLICATION FOR ROAD AND MINERAL PROCESSING SITE LEASE COVERING STATE SOVEREIGN LANDS OF OWENS LAKE, INYO COUNTY; GUY L. WEATHERLY - W.O. 4484, P.R.C. 2976.1.

After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO GUY L. WEATHERLY A 15-YEAR LEASE FOR A ROAD AND MINERAL-PROCE.SING SITE AT AN ANNUAL RENTAL OF \$733.07, THE FIRST AND LAST YEARS' RENTAL PAYABLE IN ADVANCE. THE LEASE IS TO PROVIDE FOR A \$1000 SURETY BOND AND FOR THREE RENEVAL PERIODS OF TEN YEARS EACH. THE LANDS TO BE LEASED ARE DESCRIBED AS FOLLOWS:

An application has been received from Guy L. Weatherly for a lease covering 221.47 acres more or less of State sovereign lands of Owens Lake, Inyo County (see Exhibit "A") to be used for a road and for a processing site in conjunction with Mineral Extraction Lease P.R.C. 2967.1 which the Commission approved at its meeting of December 6, 1962.

The lease is to be for a period of 15 years, with three ten-year renewal periods; the first and last years' rental will be payable in advance. The rental, based on Commission policy, will be \$733.07 per year, with a \$1000 surety bond being required.
