THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO AMERICAN TELEPHONE AND TELEGRAPH COMPANY AN EASEMENT FOR 49 YEARS, IN THE FORM ATTACHED AS EXHIBIT "A", AT A TOTAL RENTAL OF \$150, COVERING THE FOLLOWING-DESCRIBED LAND:

A STRIP OF LAND 20 FEET IN WIDTH, WITHIN SECTION 36, T. 12 N., R. 5 E., S.B.M., SAN BERNARDINO COUNTY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

APPLICATION FOR COAXIAL CABLE EASEMENT OVER STATE SCHOOL LANDS, SECTION 36, T. 12 N., R. 5 E., S.B.B.& M., SAN BERNARDINO COUNTY; AMERICAN TELEPHONE AND TELEGRAPH COMPANY - W.O. 4658.

The American Telephone and Telegraph Company has applied for an easement covering 0.457 acre more or less of State school lands in Section 36, T. 12 N., R. 5 E., S.B.B.& M. (see Exhibit "B"), for the construction, use, and maintenance of an underground coaxial cable with necessary underground structures.

This is part of a uniform 20-foot-wide easement which will extend across the continent; from California to Hawaii and Japan; and from New York to Western Furope. All of the cable and the buildings will be underground and constructed as indestructibly as possible so as to remain operable in case of national emergency. A large portion of this cable will be used by the United States government.

The land was appraised by the staff and the minimum total rental of \$150 was found to apply. The standard form desired by applicant for the easement is included as Exhibit "A".
