Mineral Extraction Leases P.R.C. 1511.2 and P.R.C. 1512.2 were issued on April 28, 1955, for an initial period of 20 years, to H. T. Leckman, Jr., and by assignments are now held by California Minerals Corporation, a California corporation.

Mineral Extraction Leases P.R.C. 2786.2, P.R.C. 2787.2, and P.R.C. 2788.2 were issued on October 20, 1961, for an initial period of 20 years, to California Minerals Corporation.

Mineral Extraction Leases P.R.C. 2809.2, P.R.C. 2810.2, and P.R.C. 2811.2 were issued on November 28, 1961, for an initial period of 20 years, to California Minerals Corporation.

Ail of the foregoing leases require that any assignment or sublease be approved by the State Lands Commission.

An application has been received from California Minerals Corporation requesting the approval of the assignment of 50 percent interest in Mineral Extraction Leases P.R.C. 1511.2, P.R.C. 1512.2, P.R.C. 2786.2, P.R.C. 2787.2, P.R.C. 2788.2, P.R.C. 2809.2, P.R.C. 2810.2, and P.R.C. 2811.2 for an initial period of 10 years to Mineral Materials Company, a partnership composed of C. W. Dunton and A. S. Vinnell, and, subsequently, the approval of a sublease of the aforesaid mineral extraction leases from California Minerals Corporation and Mineral Materials Company, joint venturers doing business under the fictitious firm name of California Asbestos Company, to the Atlas Corporation, a Delaware corporation, for an initial period of 10 years.

The proposed sublessee, Atlas Corporation (successor by merger to the Hidden Splendor Mining Company), is reportedly well versed in mining operations, having mined a total of 376,810 tons of uranium ore during 1961. It has also carried out geological and geophysical investigations and field work on numerous prospects covering a variety of minerals in 11 states.

All rental fees and royalties due the State under these leases have been paid, and the statutory filing fees in the amount of \$5 for the assignment of each lease have been remitted.
