4. APPLICATION TO AMEND LEGAL DESCRIPTION, PERMIT P.R.C. 3009.9, FOUR ARTIFICIAL REEF SITES IN SAN PEDRO CHANNEL, ORANGE COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 4942.

After consideration of Calendar Item 2 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE STATE DEPARTMENT OF FISH AND GAME AN AMENDMENT TO LETTER PERMIT P.R.C. 3009.9, ALTERING THE LEGAL DESCRIPTION OF THE CENTER POINTS OF THE FISH-PROPAGATION REEFS TO READ AS FOLLOWS:

APPLICATION TO AMEND LEGAL DESCRIPTION, PERMIT P.R.C. 3009.9, FOUR ARTIFICIAL REEF SITES IN SAN PEDRO CHANNEL, ORANGE COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 4942.

An application has been received from the Department of Fish and Game for an amendment of the location for the placement of four underwater fish-propagation reefs off the coast of Orange County, as authorized by the Commission at its meeting on May 23, 1963. The requested changes are to avoid conflict with the practice mine-laying and mine-sweeping activities of the U. S. Navy (see Exhibit "A").

All other terms and conditions of the permit are to remain the same.
