Lease P.R.C. 153.1, Sacramento County	For wharves and appurtenant loading facilities.
Lease P.R.C. 187.1, Contra Costa County	For the maintenance and operation of a wharf and marine terminal.
Lease P.R.C. 272.1, Monterey County	For the placement, maintenance, and operation of a submarine oil loading and unloading line and cathodic protection circuit.
Lease P.R.C. 331.1, Contra Costa County	Right-of-way easement for oil pipe lines and telephone cables.
Lease P.R.C. 388.1, Sacramento County	For a loading dock and dolphins.
Lease P.R.C. 419.1, Contra Costa County	For construction, maintenance, and use of a wharf.
Sublease P.R.C. 502.1, Del Norte County	For the construction and operation of a bulk storage plant.
Lease P.R.C. 2102.1, Napa County	For construction, operation, and maintenance of a pier, walkway, and 4-pile dolphins.
Lease P.R.C. 2869.1, Contra Costa County	For maintenance and operation of an oil loading and unloading wharf.
