

MINUTE ITEM

3. APPLICATION FOR EXTENSION OF TERM OF PERMIT P.R.C. 2585.9, TIDE AND SUBMERGED LANDS OF SACRAMENTO RIVER, CONTRA COSTA AND SOLANO COUNTIES; DEPARTMENT OF WATER RESOURCES - W.O. 5172.

After consideration of Calendar Item 24 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES AN EXTENSION OF THE TERM OF PERMIT P.R.C. 2585.9 TO JUNE 30, 1969. ALL OTHER TERMS AND CONDITIONS OF SAID PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT. THE CONSIDERATION FOR THIS EXTENSION IS TO BE THE PUBLIC BENEFIT.

APPLICATION FOR EXTENSION OF TERM OF PERMIT P.R.C. 2585.9, TIDE AND SUBMERGED LANDS OF SACRAMENTO RIVER, CONTRA COSTA AND SOLANO COUNTIES; DEPARTMENT OF WATER RESOURCES - W.O. 5172.

Permit P.R.C. 2585.9, covering the installation of current metering equipment, was issued to the Department of Water Resources for a term of three years beginning June 1, 1960, as authorized by the State Lands Commission on May 24, 1960 (Minute Item 7, page 5953).

An extension of the term of Permit P.R.C. 2585.9 to June 30, 1964, was authorized by the State Lands Commission on June 27, 1963 (Minute Item 7, page 8941).

By letter dated May 22, 1964, the Department of Water Resources requested "that Permit P.R.C. 2585.9 be renewed for the period June 30, 1964 to June 30, 1969", a five-year period.

The consideration for the extension-renewal is to be the public benefit.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES AN EXTENSION OF THE TERM OF PERMIT P.R.C. 2585.9 TO JUNE 30, 1969. ALL OTHER TERMS AND CONDITIONS OF SAID PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT. THE CONSIDERATION FOR THIS EXTENSION IS TO BE THE PUBLIC BENEFIT.
