4. APPLICATION FOR MINOR-STRUCTURE PERMIT FOR YACHT-RACING-COURSE MARKER-BUOYS IN SAN PEDRO BAY, LOS ANGELES AND ORANGE COUNTIES; ALAMITOS BAY YACHT CLUB- W.O. 5056, P.R.C. 3152.1.

After consideration of Calendar Item 26 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE ALAMITOS BAY YACHT CLUB A FIVE-YEAR MINOR-STRUCTURE PERMIT, AT A CHARGE OF \$25, FOR THE INSTALLATION OF EIGHT YACHT-RACING-COURSE MARKER-BUOYS. THE LOCATIONS ARE AS FOLLOWS:

APPLICATION FOR MINOR-STRUCTURE PERMIT FOR YACHT-RACING-COURSE MARKER-BUOYS IN SAN PEDRO BAY, LOS ANGELES AND ORANGE COUNTIES; ALAMITOS BAY YACHT CLUB - W.O. 5056.

An application has been received from the Alamitos Bay Yacht Club, Long Beach, for approval of a minor-structure permit for the location of eight spar-type yacht-racing-course marker-buoys in San Pedro Bay (see Exhibit "A").

The buoys would be constructed of sections of plastic irrigation pipe, 6 inches in diameter and 20 feet long, weighted at one end and filled with plastic foam. They would be anchored at the approximate locations shown on Exhibit "A". That portion above the water line would be painted with alternate bands of international orange and white reflective material.

The U. S. Army Corps of Engineers has approved the issuance of its permit.

In accordance with Commission policy with regard to minor structure permits, a \$25 charge for a five-year term would apply.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE ALAMITOS BAY YACHT CLUB A FIVE-YEAR MINOR-STRUCTURE PERMIT, AT A CHARGE OF \$25, FOR THE INSTALLATION OF EIGHT YACHT-RACING-COURSE MARKER-BUOYS. THE LOCATIONS ARE AS FOLLOWS:
