

MINUTE ITEM

6. APPLICATION FOR MINOR-STRUCTURE PERMIT ON STATE-OWNED SOVEREIGN LANDS OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; W. J. HARLAMERT - W.O. 5186, P.R.C. 3190.1.

After consideration of Calendar Item 16 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A FIVE-YEAR MINOR-STRUCTURE PERMIT TO W. J. HARLAMERT, AT A TOTAL RENTAL OF \$25, ON THE FOLLOWING-DESCRIBED LANDS:

A STRIP OF TIDE AND SUBMERGED LAND 60 FEET WIDE IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, SITUATE ADJACENT TO THE PROPERTY DESCRIBED AS A PORTION OF DIVISION B BRADFORD RECLAMATION DISTRICT NO. 2059, PER MAP 026 AT PAGE 010; BEING 30 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTER LINE:

COMMENCING AT THE INTERSECTION OF THE WEST LINE OF PAR. 1 PER BK. 3727 AT PAGE 151 OFFICIAL RECORDS OF CONTRA COSTA COUNTY (SAID LINE BEING THE EAST PROPERTY LINE OF EDWARD LOGUE) AND THE MEAN HIGH TIDE LINE ON THE LEFT BANK OF THE SAN JOAQUIN RIVER WHICH BEARS N. 58° 50' W. 5,400 FEET, MORE OR LESS, FROM U.S.C.& G.S. TRIANGULATION STATION "BRAD 1931"; THENCE NORTHEASTERLY ALONG THE MEAN HIGH TIDE LINE APPROXIMATELY 65 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE NORTHERLY INTO THE SAN JOAQUIN RIVER 30 FEET; CONTAINING 0.041 ACRE MORE OR LESS.

APPLICATION FOR MINOR-STRUCTURE PERMIT ON STATE-OWNED SOVEREIGN LANDS OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; W. J. HARLAMERT - W.O. 5186.

William J. Harlamert, who is the owner of adjacent upland on Bradford Island, has applied for a five-year permit for construction of a private, noncommercial fixed wharf, floating wharf and walkway in the San Joaquin River at Bradford Island, Contra Costa County (see Exhibit "A").

The statutory \$5 filing fee and advance deposit of \$25 have been received.

The total rental for the five-year period is to be \$25, in conformance with established Commission policy.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A FIVE-YEAR MINOR-STRUCTURE PERMIT TO W. J. HARLAMERT, AT A TOTAL RENTAL OF \$25, ON THE FOLLOWING-DESCRIBED LANDS:

A STRIP OF TIDE AND SUBMERGED LAND 60 FEET WIDE IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, SITUATE ADJACENT TO THE PROPERTY DESCRIBED AS A PORTION OF DIVISION B BRADFORD RECLAMATION DISTRICT NO. 2059, PER MAP 026 AT PAGE 010; BEING 30 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTER LINE:

COMMENCING AT THE INTERSECTION OF THE WEST LINE OF PAR. 1 PER BK. 3727 AT PAGE 151 OFFICIAL RECORDS OF CONTRA COSTA COUNTY (SAID LINE BEING THE EAST PROPERTY LINE OF EDWARD LOGUE) AND THE MEAN HIGH TIDE LINE ON THE LEFT BANK OF THE SAN JOAQUIN RIVER WHICH BEARS N. 58° 50' W. 5,400 FEET, MORE OR LESS, FROM U.S.C. & G.S. TRIANGULATION STATION "BRAD 1931"; THENCE NORTHEASTERLY ALONG THE MEAN HIGH TIDE LINE APPROXIMATELY 65 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE NORTHERLY INTO THE SAN JOAQUIN RIVER 30 FEET; CONTAINING 0.041 ACRE MORE OR LESS.
