

MINUTE ITEM

5. APPLICATION FOR DREDGING PERMIT, MORRO BAY, SAN LUIS OBISPO COUNTY;
CITY OF MORRO BAY - W.O. 5413, P.R.C. 3215.9.

After consideration of Calendar Item 43 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE CITY OF MORRO BAY A PERMIT TO DREDGE APPROXIMATELY 60,000 CUBIC YARDS OF MATERIAL WITHOUT PAYMENT OF ROYALTY FROM SOVEREIGN LANDS IN MORRO BAY. THE AREA OF THE PROPOSED DREDGING OPERATION IS DESCRIBED AS FOLLOWS:

COMMENCING AT STATION NO. 42, AS SHOWN ON MAP OF THE GRANT TO COUNTY OF SAN LUIS OBISPO, CHAPTER 1076, STATUTES OF 1947, VICINITY OF MORRO BAY, SAN LUIS OBISPO COUNTY, CALIFORNIA, BY DONALD B. DAVIDSON, DATED 11 SEPTEMBER 1957, AND FILED FOR RECORD IN THE COUNTY OF SAN LUIS OBISPO IN BOOK OF MISCELLANEOUS MAPS, PAGE 2; THENCE SOUTH 55° WEST 100 FEET; THENCE SOUTH 34° EAST 450 FEET TO A POINT WHICH IS THE TRUE POINT OF COMMENCEMENT; THENCE SOUTH 34° EAST 1,950 FEET; THENCE NORTH 11° WEST 800 FEET; THENCE NORTH 35° WEST 750 FEET; THENCE NORTH APPROXIMATELY N. 66° 51' 25" W. 552.02 FEET MORE OR LESS TO A POINT WHICH IS THE TRUE POINT OF COMMENCEMENT.

THE CONSIDERATION FOR THE ISSUANCE OF THE PERMIT IS THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, MORRO BAY, SAN LUIS OBISPO COUNTY; CITY OF MORRO BAY - W.O. 5413.

An application has been received from the City of Morro Bay to dredge approximately 60,000 cubic yards of material. The dredging operation will be beneficial to the general navigation in Morro Bay Harbor and the material will be deposited on lands granted by the State to the County of San Luis Obispo.

Section 6303 of the Public Resources Code provides, in part: "The Commission may grant the privilege of depositing material upon or removing or extracting material from...tide or submerged lands, ...owned by the State, for improvement of navigation, ...upon such terms and conditions and for such consideration as will be for the best interests of this State."

The U. S. Corps of Engineers has issued a Department of the Army permit authorizing the conduct of dredging operations at the location described in the application.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE CITY OF MORRO BAY A PERMIT TO DREDGE APPROXIMATELY 60,000 CUBIC YARDS OF MATERIAL WITHOUT PAYMENT OF ROYALTY FROM SOVEREIGN LANDS IN MORRO BAY. THE AREA OF THE PROPOSED DREDGING OPERATION IS DESCRIBED AS FOLLOWS:
