

MINUTE ITEM

18. APPLICATION FOR TERMINATION OF P.R.C. 3199.1, MINOR-STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS OF TAYLOR SLOUGH, CONTRA COSTA COUNTY; LLOYD N. INSLEE - W.O. 5328.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED (1) TO ACCEPT FROM LLOYD N. INSLEE A QUITCLAIM DATED DECEMBER 2, 1964, THEREBY TERMINATING PERMIT P.R.C. 3199.1, COVERING 0.049 ACRE OF TIDE AND SUBMERGED LAND OF TAYLOR SLOUGH, CONTRA COSTA COUNTY; AND (2) ISSUE A PERMIT FOR THE CONSTRUCTION AND MAINTENANCE OF A RECREATIONAL PIER AT THE SAME LOCATION.

APPLICATION FOR TERMINATION OF P.R.C. 3199.1, MINOR-STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS OF TAYLOR SLOUGH, CONTRA COSTA COUNTY; LLOYD N. INSLEE - W.O. 5328.

Permit P.R.C. 3199.1 was issued to Lloyd N. Inslee for a period of five years beginning October 22, 1964, for the construction of a floating boathouse, bulkhead, and walkway on 0.049 acre of tide and submerged lands of Taylor Slough, Contra Costa County.

The fee charged was \$25, in accordance with the policy followed in issuing a noncommercial minor-structure permit.

Investigation undertaken at the request of the permittee indicates that a recreational pier permit should be issued in lieu of the minor-structure permit.

The permittee has submitted for acceptance a quitclaim deed, dated December 2, 1964, to the lands covered in Permit P.R.C. 3199.1.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER (1) TO ACCEPT FROM LLOYD N.
