## MINUTE ITEM

5. APPLICATION TO AMENO SEVER OUTFALL EASEMENT P.R.C. 2237.9, GULF OF SANTA CATALINA, ORANGE COUNTY; DANA POINT SANITARY DISTRICT - W.O. 5499.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE AN AMENDMENT OF EASEMENT P.P.C. 2257.9 TO INCORPORATE THE FOLLOWING NEW LEGAL DESCRIPTION:

A STRIP OF TIDE AND SUBMERGED LAND TO FEET WIDE IN THE GULF OF SANTA CATALINA, ORANGE COUNTY, CALIFORNIA, SITUATE ADJACENT TO DOHENY BEACH STATE PARK; BEING 15 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

BEGINNING AT A FOLIT ON THE 1964 MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA AS SAME IS SHOWN ON A MAP OF A "SURVEY OF THE MEAN HIGH TIDE LINE ALONG THE SHORE OF THE GULF OF SANTA CATALINA", SHEET 1 OF 2 ON FILE IN THE OFFICE OF THE COUNTY SURVEYOR OF ORANGE COUNTY AS PLAN NUMBER 8083, SAID MAP ALSO BEING ON FILE WITH THE CALIFORNIA DIVISION OF STATE LANDS UNDER WORK ORDER 4769; DAID POINT OF BEGINNING BEARS S. 8° 19' 11" E. 444.24 FEET MORE OR LESS FROM A 1 INCH STEEL REINFORCING ROD WITH A CHISELED CROSS ON TOP, SAID RETIFEORCING ROD BEING LOCATED ON THE WESTERLY BOUNDARY OF RANCHO BOCA DE LA PLAYA AND HAVING CALIFORNIA ZONE 6 COORDINATES OF X = 1,551,412.62, 2 = 474,906.23, AND ALSO BY 5 SHOWN ON THE AFORE-MENTIONED MAP; THENCE FROM THE FOINT OF BEJINNING S. 32° 20' 23" W. 52.77 FEET, S. 1° 12' 32" W. 1,885.92 FEET, S. 22° 42' 28" E. 799.96 FEET AND S. 15° 25' 30" W. 1,199.95 FEET; CONTAINING 2.712 ACRES MORE OR LESS.

THE SIDELITIES AT THE NORTHERLY TERMINUS OF THE ABOVE-DESCRIBED STRIP OF TIDE AND SUBMERGED LAND ARE TO BE SHORTENED OR LENGTHENED SO AS TO TERMINATE ON THE MEAN HIGH TIDE LINE OF 1964.

THE BEARTI'GS AND DISTANCES USED IN THE ABOVE DESCRIPTION ARE BASED ON THE CALIFORNIA COORDINATE SYSTEM ZONE 6.

APPLICATION TO AMEND SEWER OUTFALL EASEMENT P.R.C. 2237.9, GULF OF SANTA CATALINA, ORANGE COUPLY; DANA POINT SANT ARY DISTRICT - W.O. 5499.

Sewer outfall Easement P.A.C. 2237.9 was issued to the Dana Point Sanitary District for a period of 49 years beginning September 10, 1958. The easement covers a parcel of land 30 feet wide and 2,000 feet long in the Gulf of Santa Catalina, near Doneny Beach State Park, Orange County. (See Exhibit "A".)

Because of expanded onshore facilities, it has become necessary to extend the outfall line an additional 2,000 feet.

The proposed construction has received the approval of the Regional Water Pollution Control Board and of the Department of the Army, Corps of Engineers.

It is proposed to emend the easement by the deletion of the present legal description and by the substitution therefor of a legal description that will incorporate both the original easement and the area needed for the 2,000-foot extension of the outfall line.

SAID MAP ALSO BEING ON FILE WITH THE CALIFORNIA DIVISION OF STATE LANDS UNDER WORK ORDER 4769; SAID POINT OF BEGINNING BEARS S. 8' 19' 11" E. 444.24 FEET MORE OR LESS FROM A 1 HICH STEEL REINFORCING ROD WITH A CHISELED CROSS ON TOP, SAID REINFORCING ROD BEING LOCATED ON THE WESTERLY BOUNDARY OF RANCHO EOCA DE LA PLAYA AND HAVING CALIFORNIA ZONE 6 CO&RDINATES OF X = 1,561,412.62, Y = 474,906.23, AND ALSO BEING SHOWN ON THE AFOREMENTIONED MAP; THENCE FROM THE POINT OF BEGINNING S. 32° 20' 23" W. 52.77 FEET, S. 1° 12' 32" W. 1,885.92 FEET, S. 22° 42' 28" E. 799.96 FEET AND S. 15° 25' 30" W. 1,199.95 FEET; CONTAINING 2.712 ACRES MORE OR LESS.

THE SIDELINES AT THE MORTHE LY TERMINUS OF THE ABOVE-DESCRIBED STRIP OF TIDE AND SUBMERGED LAND ARE TO BE SHORTENED OR LENGTHENED SO AS TO TERMINATE ON THE CHAIN HIGH TIDE LINE OF 1964.
