THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER FOR LEASE, PURSUANT TO COMPETITIVE PUBLIC BIDDING, THE AREA OF LAND IN THE BED OF OWENS LAKE MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED, TILIZING THE FORM OF LEASE APPROVED BY THE OFFICE OF THE AUTORNEY GENERAL, AT AN ANNUAL RENTAL OF \$2.50 PER ACRE AND AT A MINIMUM ROYALTY RATE ON ALL MINERALS EXTRACTED AND/OR PRODUCED AND/OR SOLD FROM THE STATE LANDS AND FROM THE WATERS OF OWENS LAKE, IN THE SUM OF FIFTY CENTS (\$0.50) PER TON, OR TWO PER CENT (2%) OF THE AVERAGE BULK VALUE RECEIVED F.O.B. THE PLANT AT OWENS LAKE, WHICHEVER IS THE GREATER, FOR ALL MINERALS.

APPLICATION FOR MINERAL EXTRACTION LEASE, OWENS LAKE, INYO COUNTY; PITTSBURGH PLATE GLASS COMPANY - W.O. 5429.

An application has been received from the Pittsburgh Plate Glass Company for a mineral extraction lease and for a right-of-way for pipe lines and appurtenences on an area 100 feet wide and 39,688.68 feet long, containing a total of 91.11 acres more or less in the dry bed of Owens Lake, located in portions of Sections 20, 21, 22, 27, 28, 29, 32, 34 and 35, T. 17 S., R. 37 E., and a portion of Section 3, T. 18 S., R. 37 E., M.D.B.& M., Inyo County. Minerals will be extracted from brine produced by wells drilled into the bed of the Lake.

The Department of Parks and Recreation of the Division of Beaches and Parks has reported that the issuance of a lease would have no effect upon any program or project of that Department, and that there are no known recreational activities on these lands or on land littoral which would be adversely affected by the lease. The Department of Fish and Game has reported that the operation will not interfere with any use of the area which comes within its jurisdiction. The Office of the Aktorney General has advised that the application complies with applicable provisions of the statutes and the rules and regulations of the State Lands Commission.

The lands are recession lands, and may be leased pursuant to Section 6991 of the Public Resources Code. The form of lease has been approved by the Office of the Attorney General.

The statutory flling fee and the required expense deposit have been submitted.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO OFFICE FOR LEASE, PURSUANT TO COMPETITIVE PUBLIC BIDDING, THE AREA OF LAND IN THE BED OF OWENS LAKE MORE PARTICULARLY DESCRIPED IN EXHIBIT "A" ATTACHED, UTILIZING THE FORM OF LEASE APPROVED I HE OFFICE OF THE ATTORNEY GENERAL, AT AN ADMUAL RENTAL OF \$2.50 PER ACRE AND AT A MINIMUM ROYALITY RATE ON ALL MINERALS EXTRACTED AND/OR PRODUCED AND/OR SOLD FROM THE STATE LANDS AND FROM THE WATERS OF OWENS LAKE, IN THE SUM OF FIFTY CENTS (\$0.50) PER TON, OR TWO PER CENT (2%) OF THE AVERAGE BULK VALUE RECEIVED F.O.B. THE PLANT AT OWENS LAKE, WHICHEVER IS THE GREATER, FOR ALL MINERALS.
