MINUTE ITEM

17. PROFOSED OIL AND GAS LEASE, VENTURA COUNTY - W.O. 5500 (FARCEL 25).

After consideration of Calendar Item 16 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER A PARCEL OF TIDE AND SUBMERGED LANDS IN VENTURA COUNTY FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-EONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF AN OIL AND GAS LEASE.

THE BID-LEASE FORM TO BE USED FOR THE PARCEL SHALL BE THE FORM APPROVED AND ADOPTED BY THE COMMISSION ON NOVEMBER 15, 1960, AND AMENDED NOVEMBER 6, 1963. THE LEASE RENTAL IS TO BE \$1 PER ACRE PER YEAR.

TO THE INTERSECTION WITH AN ENVELOPE LINE EVERY POINT OF WHICH IS AT A DISTANCE OF 3 GEOGRAPHICAL MILES FROM THE NEAREST POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL; THENCE NORTHWESTERLY ALONG SAID ENVELOPE LINE TO ITS INTERSECTION WITH A LINE PARALLEL TO AND 13,500 FEET DISTANT NORTH-WESTERLY AT RIGHT ANGLES FROM THE SOUTHEASTERLY EOUNDARY OF THIS PARCEL; THENCE N. 72° 43' 00" E. ALONG SAID PARALLEL LINE TO THE INTERSECTION WITH THE ABOVE MENTIONED AMAN HIGH TIDE LINE; THENCE SOUTHEASTERLY ALONG THE MEAN HIGH TIDE LINE TO THE POINT OF BEGINNING, AND EXCEPTING FROM THE ABOVE-DESCRIBED PARCEL STATE OIL AND GAS LEASE P.R.C. 735.1, RESULTING IN A NET ACREAGE INCLUDED IN PARCEL 25 OF APPROXIMATELY 5,430 ACRES.

PROPOSED OIL AND GAS LEASE, VENTURA COUNTY - W.O. 5500 (PARCEL 25).

Pursuant to the sequential bidding procedures approved by the State Lands Commission on November 15, 1960, for oil and gas lease offers of tide and submerged lands under the jurisdiction of the Commission, it is suggested the offshore area in the Santa Barbara Channel at Montalvo near the mouth of the Santa Clara River, designated as W.O. 5500 (Parcel 25) in Ventura County, be considered for lease offer.
