

4. APPLICATION FOR PERMIT TO OCCUPY AND TO CONSTRUCT A BRIDGE AND LOADING DOCK ON STATE LAND IN ANDERSON CREEK AT READING ISLAND, SHASTA COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5752, P.R.C. 3349.9.

After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF FISH AND GAME A FORTY-FIVE-YEAR PERMIT TO ERECT A BRIDGE, LAUNCHING RAMP AND DOCK ON TWO PARCELS OF SUBMERGED LAND IN THE BED OF ANDERSON CREEK AT READING ISLAND, SHASTA COUNTY, BEING FURTHER DESCRIBED AS FOLLOWS:

PARCEL 1

COMMENCING AT THE COMMON CORNER OF SECTIONS 33 AND 34, T. 30 N., R. 3 W., AND SECTIONS 3 AND 4, T. 29 N., R. 3 W.; THENCE S. $0^{\circ} 32' 00''$ W., 5,209.38 FEET TO A POINT ON THE EASTERLY BANK OF ANDERSON CREEK, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE S. $6^{\circ} 45' 00''$ W., ALONG THE EASTERLY BANK OF ANDERSON CREEK 302.00 FEET; THENCE N. $70^{\circ} 20' 30''$ W., 100.00 FEET TO A POINT ON THE WESTERLY BANK OF SAID ANDERSON CREEK; THENCE N. $9^{\circ} 45' 00''$ E., 302.00 FEET TO A POINT ON THE WESTERLY BANK OF ANDERSON CREEK; THENCE S. $70^{\circ} 20' 30''$ E., 82.00 FEET MORE OR LESS TO THE POINT OF BEGINNING, CONTAINING 0.63 ACRE MORE OR LESS AND BEING ADJACENT TO THAT CERTAIN PARCEL OF LAND KNOWN AS READING ISLAND (OR GOAT ISLAND), SHASTA COUNTY, CALIFORNIA.

PARCEL 2

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 5, T. 29 N., R. 3 W., M.D.B. & M., SAID POINT BEING THE COMMON CORNER OF SECTIONS 5, 8, 6 AND 7; THENCE N. $86^{\circ} 19' 02''$ E., 9,949.54 FEET; THENCE S. $85^{\circ} 32' 43''$ E., 510 FEET MORE OR LESS TO THE WESTERLY BANK OF ANDERSON CREEK; SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE CONTINUING S. $85^{\circ} 32' 43''$ E., 135.00 FEET TO THE EASTERLY BANK OF SAID ANDERSON CREEK; THENCE MEANDERING NORTHERLY ALONG THE EASTERLY BANK OF ANDERSON CREEK, A DISTANCE OF 186.00 FEET MORE OR LESS, THENCE N. $70^{\circ} 20' 30''$ W. 62.00 FEET TO A POINT IN THE CENTER LINE OF ANDERSON CREEK; THENCE N. $85^{\circ} 32' 47''$ W., 69.00 FEET TO THE WESTERLY BANK OF ANDERSON CREEK; THENCE MEANDERING SOUTHERLY ON SAID WESTERLY BANK OF ANDERSON CREEK 200.00 FEET TO THE TRUE POINT OF BEGINNING, CONTAINING 0.83 ACRE MORE OR LESS.

EXCEPTING FROM THE ABOVE PARCELS ANY LAND ABOVE THE LOW WATER MARK OF ANDERSON CREEK.

APPLICATION FOR PERMIT TO OCCUPY AND TO CONSTRUCT A BRIDGE AND LOADING DOCK ON STATE LAND IN ANDERSON CREEK AT READING ISLAND, SHASTA COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5752.

The Department of Fish and Game, in cooperation with the Wildlife Conservation Board, has requested authority to construct a bridge, launching ramp and loading dock on two parcels of submerged land of Anderson Creek at Reading Island (also known as Goat Island) in Shasta County, as shown on Exhibit "A".

The structures are part of an angling project to be built on dry land owned by the U. S. Government, and will consist of an access road, bridge across the creek, road on the island, parking area, launching ramp, loading dock, sanitary facilities, and fencing. In addition, Shasta County plans to develop camping facilities.

The term of the permit is to be forty-nine years, and the consideration to be the public use and benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF FISH AND GAME A FORTY-NINE-YEAR PERMIT TO ERECT A BRIDGE, LAUNCHING RAMP AND DOCK ON TWO PARCELS OF SUBMERGED LAND IN THE BED OF ANDERSON CREEK AT READING ISLAND, SHASTA COUNTY, BEING FURTHER DESCRIBED AS FOLLOWS:

PARCEL 1

COMMENCING AT THE COMMON CORNER OF SECTIONS 33 AND 34, T. 30 N., R. 3 W., AND SECTIONS 3 AND 4, T. 29 N., R. 3 W.; THENCE S. 0° 32' 00" W., 5,209.38 FEET TO A POINT ON THE EASTERLY BANK OF ANDERSON CREEK, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE S. 6° 45' 00" W., ALONG THE EASTERLY BANK OF ANDERSON CREEK 302.00 FEET; THENCE N. 70° 20' 30" W., 100.00 FEET TO A POINT ON THE WESTERLY BANK OF SAID ANDERSON CREEK; THENCE N. 9° 45' 00" E., 302.00 FEET TO A POINT ON THE WESTERLY BANK OF ANDERSON CREEK; THENCE S. 70° 20' 30" E., 82.00 FEET MORE OR LESS TO THE POINT OF BEGINNING, CONTAINING 0.63 ACRE MORE OR LESS AND BEING ADJACENT TO THAT CERTAIN PARCEL OF LAND KNOWN AS READING ISLAND (OR GOAT ISLAND), SHASTA COUNTY, CALIFORNIA.

PARCEL 2

COMMENCING AT THE SOUTHWEST CORNER OF SECTION 5, T. 29 N., R. 3 W., M.D.B. & M., SAID POINT BEING THE COMMON CORNER OF SECTIONS 5, 8, 6 AND 7; THENCE N. 86° 19' 02" E., 9,949.54 FEET; THENCE S. 85° 32' 43" E., 510 FEET MORE OR LESS TO THE WESTERLY BANK OF ANDERSON CREEK; SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE CONTINUING S. 85° 32' 43" E., 135.00 FEET TO THE EASTERLY BANK OF SAID ANDERSON CREEK; THENCE MEANDERING NORTHERLY ALONG THE EASTERLY BANK OF ANDERSON CREEK, A DISTANCE OF 186.00 FEET MORE OR LESS; THENCE N. 70° 20' 30" W., 62.00 FEET TO A POINT IN THE

CENTER LINE OF ANDERSON CREEK; THENCE N. 85° 32' 47" W., 69.00 FEET TO THE WESTERLY BANK OF ANDERSON CREEK; THENCE MEANDERING SOUTHERLY ON SAID WESTERLY BANK OF ANDERSON CREEK 200.00 FEET TO THE TRUE POINT OF BEGINNING, CONTAINING 0.83 ACRE MORE OR LESS.
